WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Radhe Shyam Teachers Training College, Plot No – 524, Street No. - Pipra Road, Vill – Gaurav Garh (Chainsinghpatti), PO - Pathra, Tehsil/Taluka – Chainsinghpatti, Town/City – Supaul, Dist – Supaul, Bihar – 852131 has submitted an application (**Code No.ERCAPP1398**) to the Eastern Regional Committee of NCTE for grant of recognition for conducting **B.Ed. - Copy of the Application Form

  - Staff Profile
  - Recognition letter
  - Information for having fulfilled the norms & standard and other required conditions.

5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
