Order

In exercise of the powers vested under Section 14(3) (a) of the National Council for Teacher Education (NCTE) Act, 1993, the Eastern Regional Committee grants recognition to **Govt. Primary Teachers Training Institute, Rail Ghumti, Cooch-Bihar-736 101 (West Bengal)** for **Primary Teachers Training Course** of One year duration from the academic session 2001-2002 with an annual intake of 40 students, subject to fulfilling the following conditions:

1. A duly qualified Principal shall be appointed before 31.12.2001.
2. One more teacher qualified as per NCTE norms shall be appointed before 31.12.2001.
3. The Institution shall function with four teaching staff and other supporting staff possessing the qualifications as laid down in the NCTE norms and in the salary structure prescribed by the UGC/Central Government/State Government as the case may be.
4. The existing one teacher not qualified as per NCTE norms shall acquire qualification within two years or be replaced with a qualified one.
5. The institution shall ensure library with 1500 books, laboratories, Hostel and other instructional infrastructure as per the NCTE norms within six months.
6. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/ State Government.
7. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
8. Curriculum transaction, including practical work/activities, should be organised as per the NCTE norms and standards for the course and the requirements of the affiliating university/examining body.
9. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
10. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 9 above.

If **Govt. Primary Teachers Training Institute, Rail Ghumti, Cooch-Bihar-736 101 (West Bengal)** contravenes any of the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder, or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.


