WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 District Institute of Education and Training, Jagatballavpur, Howrah, Plot No.- 320, 321, 336, 341, 343, 345, 795, Vill- Goalpota, Po- Jagatballavpur, Tehsil/Taluka- Jagatballavpur, Town/City- Howrah, Dist- Howrah, West Bengal - 711408 has submitted an application **(Code No. ERCAPP618)** to the Eastern Regional Committee of NCTE for grant of recognition for conducting D.El.Ed Course with an annual intake of 50 (fifty) by online on (mm/dd/yyyy) 9/28/2010 and hard copy of application submitted on (mm/dd/yyyy) 9/30/2010.

2. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to **District Institute of Education and Training, Jagatballavpur, Howrah, Plot No.- 320, 321, 336, 341, 343, 345, 795, Vill- Goalpota, Po- Jagatballavpur, Tehsil/Taluka- Jagatballavpur, Town/City- Howrah, Dist- Howrah, West Bengal - 711408** for conducting **D.El.Ed. Course of Elementary (level) of two years** duration with an annual intake of **50 (fifty)** from the academic session **2012-2013** under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009.

4. The recognition is subject to fulfillment of the following:

- (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

- (v) The institution shall submit the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

- Copy of the Application Form
 - Land and Building Particulars
 - Staff Profile
 - Recognition letter
 - Information for having fulfilled the norms & standard and other required conditions.

5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

6. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days of the issue of the order.
