### ORDER

1. In terms of Section 13(1) of the NCTE Act, 1993 University of Madras, Chepauk, Chennai - 600 005, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of permission for M.Ed. course of one year duration from the academic session 2004-05 with an intake of 25.

2. On scrutiny of the application submitted by the institution, the documents submitted therewith and the input received from the visiting team, the Committee has arrived at the following:

- The institution has acquired the land for setting up the institution.
- The institution has constructed the building for conducting the course of one year duration as per the plan filed with the Registrar.
- The institution has nominated the Principal and Three assistant principals for the course, which is to be approved by the Registrar of the University.

3. Now, therefore, in exercise of the powers vested under Section 13(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants permission to University of Madras, Chepauk, Chennai - 600 005, Tamilnadu to offer M.Ed. course of one year duration from the academic session 2004-05 with an annual intake of 25 students, subject to fulfilment of the following:

- The institution will ensure that Four exclusive faculty members duly approved by the University are in position for an intake of 25 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.
- The institution shall comply with the various other conditions prescribed in the NCTE Regulations.

4. Further, the permission is subject to fulfilment of any such other conditions as may be prescribed by other regulatory bodies like the State Government etc.

The institution shall submit to the Regional Council a Report at the end of each academic year along with a copy of the appointment in the University of appointments of faculty members, and the accounts duly audited by a Chartered Accountant.

4. If the institution contravenes any of the above conditions or the NCTE Act, Rules, Regulations and Orders made or Southern Regional Committee may withdraw the permission for the provisions of Section 17(1) of the NCTE Act 1979.
