- e) Wherever classes have started, in those schools, **dedicate a few periods** to take students through the virtual India Toy Fair 2021 and participate in craftwork, quiz, etc.
- f) Ensure teachers attend webinars on toy pedagogy, toy-based education, etc.
- g) Where internet live streaming is not available, arrange for TV viewing on Swayam Prabha eVidya channel where the India Toy Fair events will be broadcast live.
- Schools may take up Toy-based group-projects and link to Ek Bharat Shrestha Bharat paired State/UT
- i) Use common Hashtag (#) to be provided soon for disseminating on social media.
- j) Encourage schools to make 1 to 2 minutes videos on how they use toys/games/puzzles/puppets/activities/board games/electronic games/etc. as a tool for learning in the classrooms, and post it on the following MyGov site: https://www.mygov.in/task/my-favorite-indian-toy-videocontest/?target=inapp&type=task&nid=300431.
