Madam/Sir,

As you are aware, the main objective of the NCTE is to achieve planned and coordinated development of the teacher education system throughout the country, the regulation and proper maintenance of Norms and Standards in the teacher education system and for matters connected therewith.

The Northern Regional Committee (NRC) has been entrusted with the work of recognition (or otherwise) of Teacher Education Institutions/programmes in eight States/UTs namely Haryana, Uttar Pradesh, Himachal Pradesh, Uttarakhand, Punjab, Rajasthan, Chandigarh and Delhi.

Complaints/representations are being received in the office of NRC, NCTE regarding non-maintenance of norms/standards by the Teacher Education Institutions (TEIs) and it is also observed that in many cases the letters issued to the TEIs and their society are returning undelivered due to the incomplete/incorrect (or change in) address. Accordingly, these issues are seriously viewed by the NRC. NRC in its 310th meeting decided that all TEIs may be directed to maintain the details/records as per NCTE (Recognition norms and procedure) Regulations, 2014.

Therefore, NRC seeks your active support and compliance in achieving the mandate of NCTE and thus all the TEIs under the jurisdiction of NRC are hereby requested to ascertain the following without failure -

- 1. Your letter head must contain
 - Name of the TEIs with complete address and contact details i.e. office address, phone/mobile numbers, emails, fax numbers etc.
 - Name of the affiliating/examining university/body
 - Teacher Education programme(s) being offered by TEI
 - Year of establishment of TEI and the name of Society with complete correspondence address

- 2. Your website must be compliant of section 7(14) of NCTE (Recognition norms and procedure) Regulations, 2014.
- All the TEIs must ensure the compliance of section 8(11), 8(12), 8(13), 8(14) & section 10 of NCTE (Recognition norms and procedure) Regulations, 2014. NCTE Regulations 2014 are available at the following link https://ncte.gov.in/Website/PDF/regulation/regulation2014/english/Notification.pdf
- 4. NRC has developed a form to be filled by the TEIs (under its jurisdiction only) on or before 31.01.2020. The form is available at the following link (In case the link does not work by clicking please copy the link and paste in new tab of your browser)
