PUBLIC NOTICE

The National Council for Teacher Education (NCTE) is a statutory body that came into existence in pursuance of the National Council for Teacher Education Act, 1993 (No. 73 of 1993) on 17th August, 1995 to achieve planned and coordinated development of the teacher education system throughout the country, the regulation and proper maintenance of norms and standards in the teacher education system and for matters connected therewith.

- 2. Consequent upon the promulgation of the J&K Reorganization Act, 2019, the Union Territory of Jammu & Kashmir and Union Territory of Ladakh came under the purview of NCTE. In order to bring all TEIs of UT of Jammu & Kashmir and UT of Ladakh under the purview of Northern Regional Committee(NRC), NCTE, NCTE invited online applications vide Public Notice dated 28th July 2020 and the said applications had to be submitted by TEIs between 30.07.2020 and 31.08.2020. The said timeline was extended for various Teacher Education Programmes for the Union Territory of Jammu & Kashmir and Union Territory of Ladakh.
- 3. The NRC received a total of 140 applications from various TEIs located in the Union Territory of Jammu & Kashmir and Union Territory of Ladakh. In pursuance of the decision taken by NRC in its 429th Meeting held on 25.10.2024, in light of decision of GB of the NCTE taken in its 61th Meeting held on 05.08.2024, all 140 institutions are being given a final opportunity to update their applications/documents already submitted by them online through the Portal. It is made clear that this opportunity is not meant for inviting fresh applications.
- 4. The online application portal shall be opened for a period from November 05, 2024 to November 17, 2024 to upload the reply. The institutions concerned may submit their updated information during this period. While updating the relevant data on the portal, the Institutions other than those which have been issued Letter of Intent (LoI), are required to update the relevant documents/papers already uploaded, if required, in context of the deficiencies pointed out by NRC, NCTE either in 1st SCN or 2st SCN, in addition to the data fed in the relevant column/box. The institutions which have already been issued LoI, are required to upload the latest reply against the LoI.
- 5. This is final opportunity and no further extension/relaxation in timeline to comply with the norms and standards of NCTE, shall be granted. In case of any query, the institution may contact at 011-20893262/43152356.
