<u>ORDER</u> 23.12.2020

versus

This hearing is conducted through Video Conferencing.

1. The present petition is filed by the petitioner seeking stay of the withdrawal order dated 2.3.2020 issued by respondent No.2 whereby the recognition of the petitioner institution for running B.Ed. course has been withdrawn from the academic session 2020-21. The case of the petitioner is that the petitioner had applied and was granted recognition for running B.Ed. course with an annual intake of 100 students on 30.08.2008 for the academic session 2008-09. ERC issued a show cause notice to the petitioner on 21.02.2019. Subsequent show cause notice was also issued on 15-16.07.2019. After subsequent proceedings on 2.3.2020 ERC issued a formal withdrawal order withdrawing the recognition of the petitioner institution.

2. Learned counsel for the petitioner states that an appeal has been filed. He, however, states that the withdrawal order is effective only from the year 2020-21 and the petitioner may be permitted to participate in the counselling being an old institution.

3. A perusal of the withdrawal order dated 2.3.2020 shows that the only grievance appears to be that the petitioner was not maintaining the website. Learned counsel for the petitioner states that they are maintaining the website. Necessary documents have been annexed.

4. The petitioner is a recognised institution since 2008. The withdrawal order would create disruption to the students, teachers, faculty etc.

5. In these facts and circumstances, the petitioner is allowed to participate in the counselling for the year 2020-21. The respondent will take all consequential steps including change in the website, intimation to the concerned Department of Higher Education and to the affiliating University within four days from today.

6. The appellate authority may deal with the appeal filed by the petitioner, as per law, uninfluenced by any observations made by this court.

7. Petition is accordingly disposed of. All pending applications, if any, also stand disposed of accordingly.
