This hearing is conducted through video conferencing.

- 1. This writ petition is filed by the petitioner seeking to stay the operation of the withdrawal order dated 28.02.2020 whereby respondent No.2/ERC has withdrawn the recognition granted to the petitioner. Other connected reliefs are also sought.
- 2. The case of the petitioner is that it was granted recognition for conducting B.Ed. course with an annual intake of 100 students from the academic session 2008-2009 on 30.04.2008. Thereafter a withdrawal order was issued on 28.02.2020. An appeal was filed against the said withdrawal order. Now, I am informed that the said appeal was allowed on 16.12.2020 and the matter was remanded back to ERC.
- Learned counsel for the petitioner presses that the counselling for the current academic session is going on and the petitioner may be permitted to participate in the counselling.

- 4. In view of the above, as the appeal has been allowed, and keeping in view the fact that the petitioner is an old recognised institution, it would be in the interest justice that the petitioner is allowed to participate in the counselling for the current academic session. It is ordered accordingly.
- 5. The respondents will take all consequential steps forthwith for permitting the petitioner to participate in the counselling for the current academic session. Appropriate intimation will be sent to the concerned authority/affiliating university, to the Department of Higher Education of the concerned State and appropriate changes may be carried out forthwith on the website.
- 6. Nothing further survives in this petition. The petition is accordingly disposed of. All pending applications, if any, are also disposed of.
