- 2. Further, the institution applied for D.El.Ed. additional intake on 20.07.2013.
- 3. The online application made by the institution on 20.07.2013. Triplicate sets of hard copy of the application was dispatched by the institution on 31.07.2013 i.e. after the seven days of the online submission of the application.
