- (v) Teaching facilities are appointed on contractual basis.
- (vi) The post of HOD and two lecturers are vacant.
- (vii) Original FDRs of Rs. 5.00 lakh and Rs. 3.00 lakh is not submitted towards endowment fund and reserve fund respectively into joint account in the name of institution and RD, ERC, NCTE, Bhubaneswar.

In view of the above, the committee decided as under:

Show Cause notice be issued to the institution as to why the recognition to the institution be not withdrawn on the above points.
