As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hqrs., New Delhi under section 13 of the NCTE Act 1993 and Rule 8 of NCTE Rules. 1. The institution has not submitted the faculty list in the prescribed format duly approved by the affiliating/examining body.
2. The institution has not submitted a building plan and building completion certificate signed by a Govt. Civil Engineer.

Show Cause notice be issued to the institution as to why the recognition to the institution be not refused on the above points. The Committee therefore, provides an opportunity under section 14(3)(b) of the NCTE Act 1993 to the institution to submit its reply within 21 days from the issue of the letter before the Committee takes final decision.

After considering the records available in the file, and relevant provisions of the NCTE Act 1993, Rules, Regulations and guidelines issued by NCTE Hqrs. VTR, report of the District Magistrate of Giridih (JH) and reply received on 09.12.2014 in response to the notice issued under u/s 17, the Committee discussed the matter in detail and observed as under:

1. The various complaints against the institution were forwarded by the NCTE Hqrs. vide letter No.A67850, A71260, A74762, A76154, A77441 & A83306 dated 28.05.2013, 18.07.2013, 30.09.2013, 25.10.2013, 12.11.2013 & 11.02.2014 respectively received from different complainants.
2. The said complaints were forwarded to District Magistrate, Giridih with a request to conduct an inspection and submit the report to ERC as early as possible.
3. The District Magistrate, Giridih submitted its report vide letter dated 29.06.2014 clarifying as follows:
 - (i) The B.N. Saha D.A.V. Teacher Training institute and B.N. Saha D.A.V. Public School, Sirsia, Giridih is running in the same campus and the timing of the classes of both institutions are same which create difficulties to the students.
 - (ii) As per record provided by the institution, the land is in the name of DAV College Managing Committee, Chitra Gupta Road, New Delhi represented by Principal, B. N. Saha D.A.V. Public School, Giridih. Hence, no land is demarcated for B.N. Saha D.A.V. Teacher Training institution. Further, the institution submitted a resolution No. 56 to the inspection team mentioning that 1 acre land having four stories building in the name of APJ Abdul Kalam Block has been given to the B.N. Saha D.A.V. Teacher Training institute out of which total 4 acre land of the B.N. Saha D.A.V. Public School. But as per physical verification, the VT team constituted by the D.M., Giridih found that no such building/block in the name of APJ Abdul Kalam Block is constructed / established in the campus of the B.N. Saha D.A.V. Public School. It reveals that the institution has not its own separate land and building in the name of B.N. Saha D.A.V. Teacher Training institution.
 - (iii) In the D.M. Report, it is mentioned that the B.N. Saha D.A.V. Teacher Training institution is running in the fourth floor of the building of B. N. Saha D.A.V. Public School.
4. Show cause notice to institution was issued on 12.11.2014 on the above grounds.
5. Reply dated 09.12.2014 submitted by the institution is not satisfactory as per NCTE norms.

In view of the above, the committee decided as under:

The committee concluded that the institution is running the B.Ed course violating the NCTE Norms and Regulation 2009. The committee, therefore, decided to withdraw the recognition of the institution for B.Ed. course under Section 17(1) of the NCTE Act, 1993 from the academic session 2015-16.

As per direction of the Hon'ble High Court of Jharkhand, the said institution was inspected by the NCTE Hqrs., New Delhi under section 13 of the NCTE Act 1993 and Rule 8 of NCTE Rules. Accordingly, a show cause notice was issued to the institution on 02.12.2014.</p> <p>In response to the show cause notice, the institution submitted its reply dt. 10.12.2014 & 09.01.2015 to the ERC, NCTE, Bhubaneswar. The committee considered the report of the NCTE Hqrs as well as reply dated 10.12.2014 & 09.01.2015 submitted by the institution, the matter was discussed in detail and observed as under:</p> <ol style="list-style-type: none"> (1) The B.Ed. course is being conducted for the last 8 years in the Department of Education of the Degree College namely Jamshedpur Cooperative College. The college was to run the B.Ed. course temporarily and to shift to a new building which was proposed to be constructed on a plot of 5 acres in the college campus earmarked for the proposed B.Ed. college, no building has been constructed and the B.Ed. course is still conducted in the Department of Education having only built up area of 697.12 Sq. Mts. which is less than the required as per the NCTE norms. (2) The size of Multipurpose hall is only 1283 Sq. ft. as against the requirement of a minimum of 2000 Sq. ft. with a seating capacity of 200 persons. The library with only 486 Sq. ft. is also very small and inadequate as per the NCTE norms. Thus the infrastructural facilities available are inadequate as per the NCTE norms. (3) The institution has a stock of 2000 books which is less than the required 3000 as per norms. It subscribes to two journals and has a seating capacity for ten persons. The institution has not set up Psychology resource centre, science, mathematics and Art & Craft resource centre etc. (4) The institution has not appointed the regular HOD as per NCTE norms. There is no one in the department to supervise and guide the teachers. The University appoints lecturers on contractual basis for a period of 11 months on a consolidated salary of Rs. 22620/-. Every year the staff is recruited afresh after giving some break to the existing staff. This practice has been followed for more than seven years to ensure that the staff do not make claim for regularization. No other benefit is given to the staff. However, the institution has not appointed teaching faculty on regular basis till date. (5) The institution has not maintained the FDRs of Rs. 5 lakhs and Rs. 3 lakhs towards endowment and Reserve fund in the name of the institution and RD, ERC, NCTE, Bhubaneswar. <p>In view of the above, the committee decided as under:</p> <p>Show Cause notice be issued to the institution as to why the recognition to the institution be not refused on the above points. The Committee therefore, provides an opportunity under section 14(3)(b) of the NCTE Act 1993 to the institution to submit its reply within 21 days from the issue of the letter before the Committee takes final decision.</p>

Moti Ram Paswan, Secretary Lapamau, the matter was discussed in detail and observed as under:</p> <ol style="list-style-type: none"> 1. As per special inspection conducted by the NCTE Hqrs u/s 13 of the NCTE Act, the institution fulfills all requirements as per NCTE norms. 2. But, as per complaint dated 08.12.2014 received from Sh. The institution does not have its own land and building for running B.Ed programme.</p> <p>(2) The institution has not appointed the qualified and regular teaching faculty as per NCTE norms.</p> <p>In view of the above, the committee decided as under: Show Cause notice be issued to the institution as to why the recognition to the institution be not refused on the above points. The Committee therefore, provides an opportunity under section 14(3)(b) of the NCTE Act 1993 to the institution to submit its reply within 21 days from the issue of the letter before the Committee takes final decision.</p> <p>A copy of the letter may be endorsed to the Registrar of the Ranchi University and Secretary, Department of Higher Education, Jharkhand for information and necessary action.</p>

The case may be forwarded to NCTE Hqrs for seeking clarification as to whether the application for C.P.Ed course submitted under NCTE Regulation 2007 can be processed under the NCTE Regulation 2014 wherein the norms of C.P.Ed course is not framed/notified. The NCTE Hqrs is requested to suggest the further course of action to be taken by ERC in this matter. The case is listed for next hearing on 23rd March 2015 in the Hon'ble High Court of Patna.
