				<ul> <li>The Committee observed that the Hon'ble Court vide its Order dated 25.01.2022 inter-alia directed NCTE to report to Court as to whether the roofing on the fourth floor of the subject building has GIC roofing, or as contended by the appellants, RCC roofing.</li> <li>The VT Report categorically reveals that the institution is having five storied building of RCC roofing.</li> <li>The Committee decided that the VT report along with the Pen drive/CD of inspection be forwarded to the Legal Counsel of NCTE to place the same before the Hon'ble High Court.</li> </ul>
				In compliance of the above decision, the report was placed before the Hon'ble High Court through the Legal Counsel of ERC and the same has been taken on record by the Hon'ble Court <i>vide</i> Order dated 13.01.2023. Further, the Court directed Eastern Regional Committee to consider the inspection report and on the basis of report, decision has to be taken by the Regional Committee within four weeks of the said Order.
				Thereafter, in compliance of the Court Order dated 13.01.2023 in L.P.A. No. 460/2021 passed by the Hon'ble High Court of Delhi, the ERC in its319 <sup>th</sup> (Virtual) meeting held on 25 <sup>th</sup> January 2023 considered the report of inspection conducted under Section 13 of the NCTE Act 1993 by VT members on 11 <sup>th</sup> & 13 <sup>th</sup> March, 2022 and decided to issue the Show Cause Notice
