“3. Having heard learned counsel for the parties and after going through the prayer made in this application, this Court deems it fit, proper and in the interest of justice, to relegate the case of the petitioner before the Regional Director, Eastern Regional Committee, NCTC, New Delhi (respondent no.7) to consider the case of the petitioner in accordance with law.

4. In that view of the matter, the petitioner is directed to file a detailed representation along with all supporting documents before the Regional Director, Eastern Regional Committee, NCTC, New Delhi (respondent no.7) within a period of four weeks and the respondent no.7 shall dispose it in accordance with law after hearing all the concerned parties within a period of three months from the date of receipt of such representation.

5. With the direction aforesaid, this writ application stands disposed of.”

Hence, the committee decided to obtain certified land and building records from concerned revenue authorities. After receipt of the documents from the concerned authorities, the matter be placed for appropriate decision by ERC.



2. ***The institution has submitted verification of the fire safety certificate vide letter dated 12.03.2025.***


Hence, the committee observed that the reply found is satisfactory and decided that no further action is required. Complaint Division be informed accordingly with endorsement to the institution.

1. The institution has submitted faculty list approved by the Affiliating University i.e Baba Saheb Ambedkar Education University (Erstwhile WBUTTEPA), which is not in prescribed format. Seal and Signature of the approving authority is not clear.
2. The institution has submitted latest copy of renewed FDRS in respect of Endowment Fund & Reserve Fund. But the institution has not submitted Form 'A' duly signed by the Manger of the issuing bank.
3. The institution has not submitted land use certificate issued by the Competent Government Authority.
4. The institution has not submitted Non-Encumbrance Certificate issued by the Competent Government Authority.
5. The institution has submitted BCC wherein the total build up area of 8145.66 sq ft is allotted for the teacher education programme which is less than as per NCTE Regulation.
6. The institution has submitted copy of salary statement for payment of salary paid to the faculty appointed in the institution which is not clear.
7. The institution is required to submit copies of appointment letters and joining reports clearly mentioning the names and Saving Bank account numbers of each of the faculty appointed for B.Ed programme and also stating therein that the faculties are being paid salary through cheque/RTGS/NEFT. It should be supported with documents from banks, showing the disbursement of salary through bank account to individual faculty members for last six months


In view of the above, the Committee has decided that Final Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 15 days from the date of issue of show cause notice on the above deficiencies.


