In that view of the matter, the petitioner is directed to file a detailed representation along with all supporting documents before the Regional Director, Eastern Regional Committee, NCTC, New Delhi (respondent no.7) within a period of four weeks and the respondent no.7 shall dispose it in accordance with law after hearing all the concerned parties within a period of three months from the date of receipt of such representation.

5. With the direction aforesaid, this writ application stands disposed of."
