The institution is still deficient on the following in light of NCTE Regulations, 2014:

- (i)The land documents are in regional language. The Plot Nos. mentioned in the translated copy of land documents do not match with the Plot nos. mentioned in Building Completion Certificate, Change of Land Use Certificate and Building Plan.
- The built up area mentioned in VT report mismatch with Building Completion Certificate. (ii)
- In the photocopy of approved faculty list submitted, percentage of marks in Master's degree in (iii) school subject not mentioned in respect of faculty at Sl. No.3 and percentage of marks is hand written in respect of faculty at Sl. No. 7 of the list.
- (iv) Photocopy of FDR of Rs.5.00 lakh towards Endowment Fund for D.El.Ed. course bearing no.MTL/A 858670 dated 04.01.2019 mentioned in the VT report is not attached. Copy of bank authorization letters in Form 'A' is not attached.
- Fire Safety certificate issued by the Competent Authority is not submitted. (1)
- (vi) Building Safety Certificate issued by the Competent Authority is not submitted.

(vii) A certificate to the effect that the institutional campus, building furniture is disabled friendly as per the persons with disability (PWD) issued by the Competent Authority is not submitted. Hence, show cause notice under section 17(1) of the NCTE. Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice."

- (v) Fire Safety certificate issued by the Competent Authority is not submitted.
- (vi) Building Safety Certificate issued by the Competent Authority is not submitted.
- (vii) A certificate to the effect that the institutional campus, building furniture is disabled friendly as per the persons with disability (PWD) issued by the Competent Authority is not submitted.
- (viii) Land documents is not certified as photocopy of sale deed and translated copy of sale deed are submitted, however original notarized and certified sale deed along with original translated copy not submitted.
- (ix) Land documents is in the name of Secretary, Cooch Behar Advancement and Prosperity Society.
- (x) Land use certificate is provided in an affidavit by Gram Pradhan as it should be issued by concerned Land Authority.
- (xi) Photocopy of Building completion certificate is provided, which is required in original.
- (xii) Staff list shows that the staff appointed on 1.10.2018 but they are not NET/Ph.D qualified.
- (xiii) As per the VT report, playground is not well maintained.
- (xiv) The institution is running B.Ed and D.El.Ed programme, however the name of the course is not shown in Building plan and also not demarcated.

Hence, show cause potice under section 17(1) of the NCTE Act, 1993 be issued to the institution to submit reply within  $\beta 0$  days from the date of issue of show cause notice.
