The original file of the institution alongwith other related documents, NCTE Act, 1993, order of Appellate Authority, court order passed by Hon'ble High Court, Regulations and Guidelines issued by NCTE from time to time, were considered and noted by ERC:-

1. The recognition of the institution was withdrawn by ERC-NCTE on 08.06.2023.
2. The institution preferred appeal before NCTE Appellate Authority against the Withdrawal Order dated 08.06.2023 and NCTE Appellate Authority decided that the instant Appeal deserves to be rejected and therefore, the impugned Withdrawal Order dated 08.06.2023 issued by the ERC is confirmed.
3. The institution has approached the Hon'ble High Court of Patna in W.P. (C) No. 5195/2022 against the Appeal Order dated 27.02.2024 passed by the NCTE Appellate Authority and the Withdrawal Order dated 08.06.2023 passed by the ERC, NCTE.
4. The Hon'ble High Court of Patna has passed an order dated 30.01.2025 that *the submission made in paragraph no. 12 of the supplementary affidavit, the present writ application stands disposed of as having become infructuous*. The Hon'ble High court has not given any direction to NCTE for further action.

In view of above, the Committee has decided that not action is required. The institution can file an appeal before Appellate Authority of NCTE.



1. The institution is not running as per the address of the recognition order issued by NCTE.
2. The institution have no playground.
3. The institution is required to submit latest copy of renewed FDRS in respect of Endowment Fund & Reserve Fund along with Form 'A' duly signed by the Manger of the issuing bank.
4. The institution is required to submit land use certificate, Non-Encumbrance Certificate and BCC issued by the Competent Government Authority.
5. The institution is required to submit copy of salary statement for payment of salary paid to the faculty appointed in the institution.
6. The institution is required to submit copies of appointment letters and joining reports clearly mentioning the names and Saving Bank account numbers of each of the faculty appointed for D.El.Ed programme and also stating therein that the faculties are being paid salary through cheque/RTGS/NEFT. It should be supported with documents from banks, showing the disbursement of salary through bank account to individual faculty members for last six months

In view of the above, the Committee has decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 21 days from the date of issue of show cause notice on the above deficiencies.

The original file of the institution alongwith other related documents, NCTE Act, 1993, Complaint letter dated 17.09.2024, Regulations and Guidelines issued by NCTE from time to time, were considered by ERC:-

1. The College of Education, Boko offers two years B.Ed. courses without affiliation. The College has only affiliation for One year B. Ed course.
2. College of Education, Boko does not currently have a Governing Body. There is a so-called sponsoring committee that dominates the College and violates university affiliation rules. The validity of the sponsoring committee also expired on 16-05-2016.
3. According to Gauhati University (Notification Ref. No. GU/AFF/2019/9183-91 Dated 24-06-2019) Principal should be ex-officio secretary of the Governing Body of the College. However, the Principal at College of Education, Boko does not hold that position anyway.
4. As per the requirement of the NCTE and Gauhati University every B.Ed. /B.T. / Teacher Training College should include the University nominee in the interview board constituted for the recruitment of the Principal and the teaching faculty members (Notification Ref. No. GU/AFF/2019/9183-91 Dated 24-06-2019). After the notification, the College of Education, Boko violated these rules in every appointment.
5. The College of Education, Boko has also failed to pay appropriate salaries as per the UGC or similar Central Government/ State Government scale of pay. Those measures should be followed by the college in accordance with Gauhati University Notification Ref. No. GU/AFF/2019/9183-91 Dated 24-06-2019.
6. The college does not have enough teaching staff that meets the latest, NCTE standards.

In view of the above, the Committee has decided that Show Cause Notice be issued under section 17 of the NCTE Act, 1993 to the institution to submit reply within 21 days from the date of issue of show cause notice on the above deficiencies.

3. Further a readable copy of complaint may be forwarded to the concerned institution for comments as per request of the institution.




