The institution was granted recognition to B.Ed. course vide order dated 13.03.2001 with an intake of 60 from the academic session 2001-2002 by ERC, NCTE. Recognition to B.Ed. course was withdrawn under section 17(1) from the academic session 2011-2012 vide order dated 18.11.2010 and the appeal preferred by the institution against the withdrawal order was confirmed by the Appeallate Authority vide order dt. 26.04.2011.

The institution filed writ petition W.P.(C) No. 2698 of 2011 in the Hon'ble Gauhati High Court and the Hon'ble Court disposed of the matter on 02.06.2017 with the following directions:

"In view of the above, it is deemed appropriate that NCTE authorities, if they are of the view that the petitioner institution does not meet any of the required Norms and Standards as provided in the NCTE Norms and Standards of Teacher Regulation, 2001, the concerned authority may conduct a proper inspection of the petitioner institution and while conducting the inspection the representatives of the petitioner institution be also allowed to remain present.

Upon such inspection, if the NCTE find that the petitioner institution falls short of any such Norms and Standards, the same may be indicated by a show cause requiring the petitioner to either remove the deficiencies or to give reasons for the same. Upon such show cause being issued and reply being given, the appropriate authority in the NCTE would take the final decision on the question of maintainability of the recognition given to the petioner institution. In doing so, it is expected that the NCTE would give due application of mind to each and every deficiencies and also to the answer that may be given by the institution to such deficiencies and form separate reason against each individual deficiency.

The aforesaid excerise be carried out within a period of 2 (two) months from today".

In view of the above, the Committee decided as under:

Re-inspection be conducted on payment of Rs. 1,50,000/- as per NCTE Regulation, 2014 by the institution.
