- No Multi-purpose Hall as such, only one hall of approx. hundred capacity. No reading room in the library.
- Multi-purpose Hall, Humanities and Biology lab were not available.
- Humanities Stream laboratories, Activity Cum Resource Center, Health and Physical Education Room is not available.
- Fire Safety Certificate is not issued by the authority till the date.
- Multipurpose hall which the institute was claiming not seems to be multipurpose hall having only capacity of 100 seats and area seems to be approx. 1000 sq ft.
- Biology and Humanity Labs was not available in the building bu the institute was claming to have a new building of the University which is 8-9 km away from this Building which is not acceptable as per norms.
- Library books and Journal are acceptable but no reading and sitting room was available.
- Sports facilities and other extra-curricular facilities were not appropriate

In view of the above, the Committee has decided that Show Cause Notice after examine the VI report, be issued under section 14/15 of the NCTE Act, 1993 to the institution to submit reply within 21 days from the date of issue of show cause notice on the above deficiencies through online portal before passing rejection order on the above grounds.





4. The institution is required to submit Fire Safety Certificate issued by the Govt. Competent Authority.




