The matter was carefully considered by NRC in the light of the NCTE Act 1993, Rules, Regulations and Guidelines issued by NCTE from time to time and the Committee made the following observations:

- As per provision contained in Section 12 (j) & (k) of the NCTE Act, 1993, the institution was asked to fill up the Performance Appraisal report (PAR) for the academic session 2020-21, however, the institution has not filled up the same.
- Therefore, as per decision taken by ERC in its 306<sup>th</sup> meeting held on 12<sup>th</sup> to 13<sup>th</sup> July, 2022, Show Cause Notice under Section 17 (1) of NCTE Act, 1993 was issued to the institution for not filing PAR on the ground that the institution has breached the condition of recognition as per the provision of clause 8 (12) of NCTE Regulations, 2014 and also clause 7 (14) of NCTE, Regulations, 2014 which is related to uploading information on the website.


**The Committee noted that the institutions enumerated at Sl. No. 22 to 111 have submitted the reply of Show Cause Notice issued to them, however, none of the institutions has given proper justification for not filling the PAR.**

**Hence, the Committee decided the following:**

- The Final Show cause notice under section 17 (1) of NCTE Act, 1993 be issued to all the institutions enumerated at Sl. No. 22 to 111 above to submit reply within 7 days from the date of issue of final show cause notice before withdrawal of recognition on the ground that the institutions had not complied with the directions of NCTE to file PAR for the academic session 2020-21 as per mandate contained in Section 12 (j) & (k) of the NCTE Act, 1993 and had also breached the condition of recognition as per the provision of clause 8 (12) of NCTE Regulations, 2014
