The Eastern Regional Committee in its 222^{nd} meeting held on $14^{th} - 16^{th}$ September 2016 after considering and examining the application along with the documents submitted by the institution, the agenda note, the NCTE Act., the NCTE Regulations 2014 including Norms and Standards, guidelines received from the NCTE Hqrs. from time to time, VTR and reply received in response to LOI, the Committee discussed the matter in detail and decided as under:

"Formal recognition order under clause 7(16) of the NCTE Regulation 2014 for applied D.El.Ed programme with an intake 50 (one basic unit) from the academic session 2017-18 be issued to the institution".

Further, it is observed that the institution is recognised for 60 intake in D.El.Ed. programme from the session 2002-2003 and now the ERC in its 222^{nd} meeting decided to grant permission for additional intake of 50 (one unit), thus making the total intake of 110.

The intake of 110 students is not come under the categorized unit as per NCTE Regulation 2014.

In view the above, the committee decided as under:

Revised permission order for additional 40 intake be issued to the institution to make the total intake 100 i.e. two basic units of 50 each.

In order to implement the NCTE Regulations, 2014, all the existing TEIs running B.Ed. course were allowed either to have 2 or more units or to have one unit only from the academic session 2015-16. The TEIs which opted for two or more units of B.Ed. were required to appoint additional faculty & staff by 29.02.2016 and to provide the additional infrastructure as required under NCTE Regulations, 2014 before 31.10.2015 which was later on extended up to 30.05.2016.

In case of B.P.Ed., the intake has been increased to 100 students (one unit) from the existing 50 and in case of M.Ed. increased to 50 (one unit) from the existing 35 students subject to appointment of additional faculty & staff by 29.02.2016 and to provide the additional infrastructure as required under NCTE Regulations, 2014 before 31.10.2015 which was later on extended up to 30.05.2016.

The NCTE HQs., New Delhi vide its letter No. 48-11/2016/N&S/28811 dated 17.05.2016 has directed the ERC to intimate the process of monitoring of existing TEIs in compliance of the provisions of NCTE Regulation, 2014.

The Eastern Regional Committee considered the matter in detail and observed that around 265 TEIs have not submitted the compliance to the ERC, NCTE office till date.

In view the above, the committee decided as under:

Show Cause Notice be issued to all such institutions who have not submitted the required documents like list of faculty duly approved by the affiliating body, building completion certificate in the prescribed format as well as building plan approved by any Govt. Engineer and additional FDRs as per requirement of NCTE Regulation, 2014.

The institution is already recognised for D.El.Ed. programme for one unit (50 seats) from the session 2013-14 and again applied for B.Ed. programme for two units for the session 2016-17.

The ERC vide its order No. ER-213.6(I).232/ERCAPP3072/B.Ed./2016/46161 dated 02.05.2016 granted permission for conducting one unit (50 seats) of B.Ed. programme against an application for two units.

The appellate authority vide Order No. 89-298/2016 Appeal/9th Meeting-2016/35649 dated 04.08.2016 noted that the appellant in his online application dated 30.05.2015 mentioned the name of the course applied for as B.Ed. and in the affidavit enclosed to the hard copy, he has stated that the application is for an intake of 100. The visiting Team in their report mentioned the intake as one unit (50 students). The Committee, however, noted that the ERC in their letter of intent dated 03.03.2016 <u>inter-alia</u> asked the appellant to submit consent/willingness for basic unit (one or two) for the said course. The appellant with his reply dated 20.04.2016 submitted an affidavit stating that they want two basic units (100 students) and also <u>inter-alia</u> enclosed a faculty list of one principal and 15 lectures approved by the affiliating body, both which have been taken note of by the Eastern Regional Committee as could be seen from their file. However, no reasons have been adduced for granting recognition for one basic unit only. In these circumstances, the committee concluded

that the matter deserved to be remanded to the E.R.C. with a direction to consider the request of the appellant for two units of 50 students each in the B.Ed. course and take further action as per the Regulations. The ERC reviewed the matter in accordance with the appeal order and observed that the institution has submitted a faculty list of one principal and fifteen lecturers alongwith their educational and other required documents. On verification of the mark sheets and certificates the appointed three lecturers were found invalid for the reasons mentioned below:

- (i) That the institution has appointed one faculty in education namely Suprojit Das, the B.Ed. mark sheet is a downloaded copy and has not been signed by the competent authority. Hence, his appointment has been treated as invalid.
- (ii) That the institution has appointed one faculty in political Science namely Selim Jafar, his M.Ed. marksheet is a downloaded copy and has not been signed by the competent authority. Hence, his appointment has been treated as invalid.
- (iii) That the institute has appointed one faculty of mathematics namely Sk. Soaib Mohammad Firoj, his M.Ed. mark sheet is signed by "For Registrar". Hence, his appointment has been treated as Invalid.

That it is not permissible as per the Norms & Standards as envisaged in Appendix-4 of the Regulation, 2014 of NCTE, the institution with valid faculty strength of 13 which is less than 16 for conducting Two year B.Ed. programme in two units with 200 students.

That the Norms & Standard in Appendix-4 of the Regulation, 2014 of NCTE at 5.1 (Note-1) envisages if the students strength of one unit of 50 students for Two years is 100 only, the number of faculty shall be reduced to 8 (eight).

That the Eastern Regional Committee taken up the faculty position of the institution for granting final permission in its 213^{th} meeting held on 29^{th} - 30^{th} April & 1^{st} - 2^{nd} May 2016.

That as per direction of the Hon'ble Apex Court in I.A No 9 of 2016 in W.P. (S) civil No 276/2012 Maa Vaishno Devi Mahila MahaVidlayaVs State of U.P. &Ors vide order dated 28.03.2016 the cut of date for granting recognition was 02.05.2016 for the session 2016-2017.

That the Eastern Regional Committee keeping in view the cut of date i.e. 2nd May, 2016 for granting recognition / permission for the session 2016-2017 decided not to issue show cause notice amounting to complete loosing of enrolment of students for the session 2016-2017.

That the Eastern Regional Committee in its 213th meeting held on 29th- 30th April & 1st-2nd May 2016 discussed the matter in detail and decided in terms of 5.1 (Note-1) of Appendix-4 of NCTE Regulation, 2014 to grant formal permission order under clause 7(16) of the NCTE Regulation 2014 for applied B.Ed. programme with an intake of 50 (one basic unit) from the academic session 2016-2017 in the greater interest of the institution.

That the above decision has been taken fairly to the best of its fitness in terms of the stipulation in the NCTE Regulation 2014 and any allegation to the contrary is unfounded and imaginary.
