An opportunity was again given for filling the requisite information between 17.06.2017 and 12.09.2017.</i></p> <p><i>And whereas it may be noted that the authenticated list was intended to be displayed on the NCTE website for facilitating the candidates seeking admission to recognized teacher education institutions and courses. It was deemed as a requirement for every candidate and Affiliating Body to verify from the NCTE website whether or not the institution and course is recognized by NCTE.</i></p> <p><i>However, some TEIs have not complied with the desired requirement under Regulation 8(12) and have thus violated the said Regulation.
