MADHYA PRADESH 260.4.1. Consideration of cases referred to WRC by Madhyamik Shiksha Mandal Bhopal

Teacher Education institutions are required to maintain academic atmosphere and discipline at all times and particularly:

- a) Classes should be conducted till the end of the academic year so as to ensure 200 teaching days of 36 hours a week with 80% (course work) / 90% (Internship) attendance. It is not acceptable that institutions do not conduct classes after filing in the application for examination, as stated by many institutions.
- b) The academic Calendar should be drawn up carefully with academic activities, curricular and cocurricular. This academic Calendar should be adhered to.
- c) Attendance Register of students and faculty should be maintained and these should be monitored by the head of the institution.
- d) The lesson plans/notes for daily lessons by the faculty should be maintained in a file or register. The same should be monitored by the head of the institution.
- e) All absence from the institution by the faculty should be properly recorded.
- f) Feedback from the students on the faculty should be obtained, analysed and the useful suggestions implemented. The feedback may be obtained mid-course and at the end of the session. These records should be maintained carefully.
