

**MINUTES OF THE 282nd MEETING
OF
WESTERN REGIONAL COMMITTEE, NCTE, BHOPAL**

The 282nd meeting of WRC was held on October 24-26, 2017.

Since Prof. Chandrashekhar Vazalwar, Chairperson, WRC, NCTE has expressed his inability to attend this meeting, the members of the committee unanimously decided to conduct the meeting under Chairmanship of Dr. Louis Vernal.

Shri L.S. Baghel, Prof. Freny Tarapore and the State Representatives of Gujarat expressed their inability to attend the meeting. The Representatives of Chhattisgarh, Daman & Diu and Dadra & Nagar Haveli did not give any information about their presence.

At the outset, Shri Awadhesh Nayak, Regional Director and Convener, welcomed the Chairperson and all the members of WRC, NCTE to the 282nd meeting of the WRC.

The Regional Director, being Convener of the WRC, presented each agenda item for consideration of the WRC.

The agenda were taken up as follows:-

Agenda 282.1: Confirmation of the minutes of 281st Meeting of WRC.

The minutes of the 281st Meeting were confirmed by the Committee.

Agenda 282.2: Action Taken Report of 281st Meeting of WRC.

The Action Taken Reports were noted.



1. Subject: Processing of cases under PIL NO.2370/2012.

In response to PIL No.2370/2012, the Hon'ble High Court of Madhya Pradesh, Bench at Jabalpur directed the NCTE to conduct inspection of all the B.Ed. colleges of Madhya Pradesh. The NCTE Hqrs. have been sending the VT reports from time to time which have been processed further by the WRC. So far the process of 118 cases have already been completed and action initiated.


The WRC discussed the issue and decided that the matter may be kept in abeyance for a while because NCTE Hqrs. has sought details under Mandatory Affidavit System (MAS) from all the teacher education institutions across the country. These Mandatory Declarations have been scrutinized by a team at New Delhi. These reports have been sent to WRO for further action. So far 300 defaulters have been issued Show Cause Notice as to why recognition should not be withdrawn. A large number of them have approached the Hon'ble High Court of Delhi against this action under W.P. No.9215/2017 and 9190/2017. The Hon'ble High Court has given 8 weeks' time from the date of order for the institutions to comply with the Mandatory Affidavit System, failing which action for withdrawal would be taken.

Since all the cases under the PIL will also be covered under this Mandatory Affidavit System, the WRC decided to await the result to have uptodate information.

2. Subject: Process of de-recognition of institutions due to non-compliance of filing of Mandatory Affidavit System (MAS)

As per decision taken in the 281st meeting, the institutions were required to send replies on or before 23.10.2017 for the first list and 06.11.2017 for the second list provided by the NCTE Hqrs.

However, these cases cannot be taken as scheduled because the Hon'ble High Court of Delhi vide order dated 17.10.2017 in Writ Petition No.9215/2017 has granted 8 weeks' time for filing the Mandatory Affidavits from the date of issue of order. As such, no action can be taken before the expiry of that period. NCTE Hqrs. may be informed accordingly.
