The institution is running the following courses:-</p> <ul style="list-style-type: none"> • Tilak Public Senior Secondary schooli-secondary and Sr. secondary • B.Ed.(100 students) • Shiksha Shastri (100 students) <p>The land registered before the date of application is only 3260 sq.ft, which is not sufficient for the existing and proposed courses.</p> <p>3. The institution had submitted the further additional land documents registered on 01st December 2014, which are after the date of application, hence, not acceptable. Moreover, the land mentioned at Khasra No. 289 and 290 are at different places.</p> <p>4. As per VTR the total built up area in the institution is 2768 sqm, which is not sufficient for the existing courses and proposed D.El.Ed. course.</p> <p>5. The CLU is available in respect of only Khasra No. 607 measuring 302.97 sqm.</p> <p>In view of the above, the Committee decided that the application submitted by the institution for D.El.Ed course be refused under section 15 of the NCTE Act.</p>
