The 388th Emergent Meeting of Western Regional Committee (WRC), National Council for Teacher Education was held on 03rd July 2023 through virtual mode.

1.	<p>The WRC decided that one observation made by the WRC in its 386th meeting held on 26.05.2023 at Sl.No.1 to 16, 21 and 22, which is as follows:</p> <p><i>"Considering the gravity of the matter, as LPA filed as per GB decision got dismissed and since the policy matters are involved legal opinion from the Standing Counsel of NCTE at the Supreme Court of India was sought through NCTE HQrs on the issues involved and received the same on 25.05.2023".</i></p> <p>be read as follows:</p> <p><i>"Considering the gravity of the matter, as LPA filed as per GB decision got dismissed and since the policy matters are involved, approval to the extent of seeking legal opinion was obtained from NCTE HQrs. - (ii) The size of the multipurpose hall mentioned in the VT report is 111.5 sq.mts. or 1200.176 sq.ft. which is less as per NCTE Norms and Regulations.

In view of the above, the Committee decided that Show Cause Notice prior to refusal of recognition be issued to the institution u/s 14(3)(b) of the NCTE Act on the above-mentioned point. The institution shall submit a reply accompanied by an original affidavit within 15 days from the date of issue of show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations.
