**Decision of WRC:**

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time along with letter 27.04.2023 and 9.12.2024 from institution seeking change of women to Co-Ed and change name of the institution and the Committee observed as under:

- (i) The institution has changed the name of institution from “Sanskar Girl’s College” to “Sanskar College” from the academic session 2022-2023 vide order dated 20.02.2023 of Commissioner, college education Govt of Rajasthan Jaipur without prior approval of recognizing authority WRC NCTE which is against the NCTE instructions and guidelines.
- (ii) It is pertinent to note that change of name of institution from Sanskar Girls College to Sanskar College together with change of category from women to Co-Ed doesn’t come under the purview of NCTE because in this case name of existing recognised institution is not changed; only category is changed from Girls to Co-Ed.
- (iii) NCTE vide Public Notice F.No.NCTE-Reg1022/16/2023-Reg.Sec.HQ dated: 05.02.2024 invited transaction applications in respect of recognized institutions for 4 year Integrated programme (B.A.B.Ed./B.Sc.B.Ed) to introduce ITEP in multi- disciplinary institutions with instruction that the last academic session for admission of students to 4 year integrated programme (B.A.B.Ed./B.Sc.B.Ed.) shall be 2024-2025. No fresh admissions shall be made in this course thereafter. However, those students who have enrolled upto the academic session 2024-2025 shall be allowed to complete their programme as per norms. The 4 year integrated B.Sc.B.Ed/B.A.B.Ed. programme under the omitted Appendix-13 shall be discontinued from the academic session 2025-2026. Further, it is relevant to mention that an online transition application bearing number 2526202403021977 in the name “SANSKAR COLLEGE DANTA, JEEN MATA BYEPASS ROAD, DANTARAMGARH, SIKAR, SIKAR, RAJASTHAN-332702” is under process by WRC. Any modification of name of institution at this stage is not permissible.

**In view the above, Committee decided that application of institution for change of name of institution from “Sanskar Girls College” to “Sanskar College” together with change of category from women to Co-Ed is rejected with direction not to take fresh admission of students from academic session 2025-2026 unless permission granted for transition of B.A.B.Ed./B.Sc.B.Ed to ITEP programme.**

### Decision of WRC:

The online application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- (i) This transition application is re-examined on the basis of revisit direction as per Appeal Order No.89-25/ E-337776/2024/Appeal/10<sup>th</sup> Meeting, 2024/APPLWRC202414779/126567 dated 22/08/2024. The institution has submitted off-line reply on 11/09/2024 vide their letter No. BRC/1022/2024 dtd. 07.09.2024 on the basis of direction of aforesaid Appeal Order. Now, the following deficiencies are found:

- (iii) The institution is required to upload latest affiliation order of B.A., B.Com., B.Sc. etc. (multi-disciplinary courses) and B.A B.Ed. / B.Sc. B.Ed. course.
- (iv) The institution is required to upload Not-for- Profit Certificate issued by Govt. Competent Authority i.e. Registrar of the Society as well as IT Form-10AB/10AC or IT Form-12AA/12A and also required to upload By-Laws and Exemption Certificate (12A) issued by Govt. Competent Authority.
- (v) The institution is required to upload complete details of Society/ Trust/ Company Members approved by its Society.

B.Ed. The remaining built-up area 3470 sq.m. is used for the degree courses i.e. B.A., B.Sc., BCA, B.Com., M.A. (Economics, Psychology, Pol.Science., Geography, Hindi Lit., English Lit. History, Urdu), M.Com. (EAFM & ABST), M.Sc. (Maths, Physics, Chemistry, Botany, Zoology) with combined intake of 1280. The sufficiency of the 3470 sq.m. built-up area for 1280 students cannot be ascertained. The institution is required to upload Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land and built-up area earmarked for each course being run in the premises and the demarcated land and built-up area for the teacher education programmes including multi-disciplinary programmes.

The institution is conducting degree courses i.e. B.A., B.Sc., BCA, B.Com., BBA M.A. (Maths, Geography, English, Punjabi, Pol. Science, Sociology), M.Com. (Business Management, ABST), M.Sc. (Maths, Physics, Chemistry, Botany, Zoology, Computer Science, Geography) combined intake of 1935. The sufficiency of land and built-up area for 1935 intake of multi-disciplinary courses and 100 intake for B.A.B.Ed. / B.Sc. B.Ed. course cannot be ascertained. The institution is required to upload Building Plan approved by the Competent Authority of State Government indicating the Khasra/Plot/Survey No. and mentioning the total land and built-up area earmarked for each course being run in the premises and the demarcated land and built-up area for the teacher education programmes including multi-disciplinary programmes.
- (ii) The institution is required to upload the latest list of teaching staff countersigned by the Registrar of affiliating body as per qualification contained in the NCTE Norms and Regulations as amended from time to time.

The details of the students admitted in other courses are not mentioned in the uploaded list by the institution. The institution has submitted the list of admitted students of Govind Guru Tribal University (GGTU) without countersignature but the institution's affiliating body Maharishi Dayanand Saraswati University (MDSU) has been mentioned in the application. It cannot be ascertained whether GGTU has allotted students to the applicant institution. The list of allocated students is required to be certified by the affiliating university of the applicant institution i.e. MDSU, Ajmer. It is observed from WRC records that institution is also conducting B.Ed. course however, its details are not furnished by the institution. The recognition order from NCTE along with the affiliation order of the concerned affiliating university is required to be uploaded.
- (iii) The institution has uploaded recommendation of the State Government for the year 2023-24 and 2024-25. This application is for the session 2025-26.
- (iv) The Institution has uploaded notarized affidavit regarding Land Documents in prescribed format on stamp paper of Rs. 100/- at New Khasra No. 225, 227 is mentioned but Khasra No. 226, 228 is not mentioned in Affidavit.

The institution is deficient on the following grounds of final show Notice:

Further, the institution has not uploaded Mutation Certificate of Land in respect of Kh.No. 5928/2 issued by the Revenue Department.
- (ii) The institution has uploaded copy of Land Use Certificate for educational purpose in respect of Khasra no. 5928/2 issued by District Collector without Seal. However, certified copy not uploaded by the institution.
- (iii) The institution has uploaded Non Encumbrance Certificate (NEC) at Kh. No. 5928/3 issued on 15/06/2015 by Tahsildar. This NEC is issued 10 years earlier and the present status of non-encumbrance of the land cannot be ascertained from this NEC. Further
