With permission of the Chair, Dr. Meetu Bharti, Regional Director, WRC, presented the Agenda before the Committee. Item-wise decisions taken on each agenda item are as under:

#### TAGORE B.ED COLLEGE, OPP-JAGDISH MAHARAJ TEMPLE, SAMBHARIYA ROAD, GONER, TEHSIL- SANGANER, DIST- JAIPUR, RAJASTHAN (RJ-1246) (B.ED)

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and in continuation of decision recorded in the minutes of 383<sup>rd</sup> meeting of WRC held on 20-21 April 2023, the Committee observed as under:

- (i) As per decision in 383<sup>rd</sup> meeting, final show cause notice was issued to the institution on 09.05.2023.
- (ii) Institution has submitted a reply through email dated 27.04.2023 on the basis of uploaded minutes of 383<sup>rd</sup> meeting on the website. No hard copy of reply has been received in WRC, NCTE.
- (iii) The institution is still deficient on the following grounds:
  - Original approved faculty list reflecting signature of the approving authority in original therein is not submitted.
  - Original affidavit not submitted.
  - The first to fourth page of scanned copy of faculty list (received through email) seems to have been countersigned by Deputy Registrar (Aca), University of Rajasthan on 26.12.2020 wherein official stamp affixed is not legible. On the fifth page of scanned copy of faculty list, signature of Registrar, University of Rajasthan reflected as 07.01.2021 showing modification of date.
  - Written letter of approval letter issued by the affiliating university for selection/appointment of teaching staff as per staff list is not submitted.
  - Documents related to following of laid down procedure by the duly constituted selection committee
    as per recommendations of the affiliating body for appointment of teaching faculty is not attached.
  - Educational and professional qualification testimonials and experience certificate of Principal and that of faculties appointed after 09.06.2017 has not been submitted.

 The institutional website <u>www.tagoreeducations.com</u> is not functional. Therefore, it could not be verified whether the approved faculty list is uploaded on its official website. The institution has failed to maintain and update its official website uploading all the requisite information/documents in light of Clause 7(14)(i), 8(14) and 10(3) of the NCTE Regulations, 2014 as amended from time to time.

In view of the above, the Committee decided to withdraw recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order with a copy endorsed to State Govt., Affiliating Body and others concerned. A copy of the withdrawal order shall be uploaded on the NCTE web portal.

# 2. NARESH SHIKSHAK PRASHIKSHAN MAHAVIDYALAYA, CHIRAWA ROAD, NEARBY CROSSING, SINGHANA, JHUNJHUNU, RAJASTHAN (RJ-1142) (B.ED.)

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and in continuation of decision recorded in the minutes of 385<sup>th</sup> meeting of WRC held on 17<sup>th</sup> May 2023, the Committee observed as under:

- A restoration order was issued to the institution on 19<sup>th</sup> May 2023 as per decision taken in 385<sup>th</sup> meeting.
- Vide letter dated 06.01.2023 received in WRC on 03.02.2023, the institution has submitted reply in response to the decision of the appellate authority vide order dated 21.12.2022.
- iii. The Committee considered the documents submitted vide letter dated 06.01.2023 and observed that the institution is still deficient on the following grounds:
  - In the notarized copy of Building Completion Certificate issued by Sahayak Abhiyanta, Panchayat Samiti, Buhana, Dist. Jhunjhunu, year of construction mentioned as 2016, which is contradictory on the basis of recognition order issued on 26.08.2008.
  - In the notarized copy of Fire NOC issued by Executive Engineer, the name of the institution and address/location and other relevant details are not mentioned in the letter.

In view of the above, the Committee decided that Show Cause Notice prior to withdrawal of recognition be issued to the institution u/s 17 of the NCTE Act on the above-mentioned points. The institution shall submit a reply accompanied by an original affidavit within 15 days from the date of issue of show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of show cause notice be endorsed to the State Government and Affiliating Body.

## THE NEW PROGRESSIVE COLLEGE OF TEACHER EDUCATION, PUJA BUILDING, NEAR MUNICIPAL PLAY GROUND MEHSANA-384001 GUJARAT (APW00063/323070) (B.ED.)

- Vide letter dated 15.03.2023 received in WRC on 05.04.2023, the institution has submitted reply in response to the decision of the appellate authority vide order dated 07.03.2023.

- III. The Committee considered the documents submitted vide letter dated 15.03.2023 and observed that the institution is still deficient on the following grounds:
  - Original approved staff list in NCTE prescribed proforma not submitted. Date of joining and other details as per proforma is not reflected in the approved faculty list.
  - Ph.D. certificate of Principal not submitted, instead a copy of order dated 24.02.2023 issued by I/c Registrar, Hemchandracharya North Gujarat University, Patan to newly appointed principal is attached.
  - The approved faculty list reflecting their name and details is not uploaded on the institutional
    official website (www.npcte.org).
  - The institutional website is not maintained and updated having all the requisite information in light of Clause 7(14)(i), 8(14) and 10(3) of the NCTE Regulations, 2014 as amended from time to time.

In view of the above, the Committee decided that Show Cause Notice prior to withdrawal of recognition be issued to the institution u/s 17 of the NCTE Act on the above-mentioned points. The institution shall submit a reply accompanied by an original affidavit within 15 days from the date of issue of show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of show cause notice be endorsed to the State Government and Affiliating Body.

  - Original approved faculty in NCTE prescribed proforma not submitted. The notarized scanned approved faculty list submitted is not in accordance with NCTE prescribed proforma.
  - Date of joining, subject of teaching, date of birth, age, category in respect of appointed faculties is not reflected in the scanned faculty list.
  - The approved faculty list reflecting their name and details is not uploaded on the institutional
    official website (www.npcte.org).
  - The institutional website is not maintained and updated having all the requisite information in light of Clause 7(14)(i), 8(14) and 10(3) of the NCTE Regulations, 2014 as amended from time to time.

In view of the above, the Committee decided that Show Cause Notice prior to withdrawal of recognition be issued to the institution u/s 17(1) of the NCTE Act on the above-mentioned points. The institution shall submit a reply accompanied by an original affidavit within 15 days from the date of

issue of show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of show cause notice be endorsed to the State Government and Affiliating Body.

#### LT. SARDAR SINGH SMRITI SHIKSHA SAMITI TAL DARWAJA, TIKAMGADH MADHYA PRADESH 472001 (APW01726/223305) (B.ED.)

- Vide letter dated 10.08.2020 and 17.08.2020, the institution has submitted reply in response to the decision of the appellate authority vide order dated 15.07.2020.
- III. The Committee considered the documents submitted vide letter dated 10.08.2020 and 17.08.2020 and observed that the institution is still deficient on the following grounds:
  - Original approved faculty list (1 Principal + 15 faculty) in accordance with NCTE prescribed proforma reflecting their joining date with subject of teaching not submitted by the institution.
  - The letter of university approving the faculty is addressed to The Principal, Sardar Singh Smriti Shiksha Mahavidyalaya, Tikamgarh (M.P.) whereas the name and address of institution differs from its actual name as applied/granted recognition i.e. Lt. Sardar Singh Samriti Shiksha Samiti, Tal Darwaja, Tikamgadh Madhya Pradesh 472001.
  - Photocopy of CLU dated 03.06.2011 is attached wherein office stamp affixed is not legible.
  - Photocopy of building plan (not notarized) is submitted in small font wherein the name of
    institution does not match with initial application and recognition order. Also, a stamp/seal of
    approving authority is not legible.
  - In the photocopy of building completion certificate (not notarized) submitted, name of institution does not match with initial application and recognition order.
  - The institutional website <u>www.smcedu.org</u> is not functional. The institution has failed to maintain and update its official website having all the requisite information in light of Clause 7(14)(i), 8(14) and 10(3) of the NCTE Regulations, 2014 as amended from time to time.

In view of the above, the Committee decided that Show Cause Notice prior to withdrawal of recognition be issued to the institution u/s 17(1) of the NCTE Act on the above-mentioned points. The institution shall submit a reply accompanied by an original affidavit within 15 days from the date of issue of show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of show cause notice be endorsed to the State Government and Affiliating Body.

### ARADHANA P.T.C. COLLEGE, SHREE PRANTIJ TALUKA KELAVANI TRUST, SHANTIVAN CAMPUS, GH-6 ROAD, SECTOR-28 GANDHINAGAR-382028, GUJARAT (APW01287/323201) (B.ED)

- (iii) The Committee considered the documents submitted vide letter dated 16.02.2023 and observed that the institution is still deficient on the following grounds:
  - Photocopy of building plan submitted in regional language and its notarized translated copy not submitted.
  - Original approved faculty list in NCTE prescribed proforma not submitted, instead colour scanned copy of faculty comprising 1 Principal + 10 lecturers submitted. Date of joining and other details as per proforma is not reflected in the approved faculty list.
  - Copy of appointment order, experience certificate and marksheet/ certificate regarding educational qualifications in respect of the faculty members not submitted.
  - The submitted approved faculty list is not displayed in the institutional website. Being recognized by WRC, NCTE, the institution has not developed, maintained, and uploaded/updated all related information on its official website (www.aradhanacollegeofeducation.com) in light of Clause 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014 as amended time to time.

In view of the above, the Committee decided that Show Cause Notice prior to withdrawal of recognition be issued to the institution u/s 17(1) of the NCTE Act on the above-mentioned points. The institution shall submit a reply accompanied by an original affidavit within 15 days from the date of issue of show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of show cause notice be endorsed to the State Government and Affiliating Body.

#### IITS COLLEGE, LATE SHRI BHAGWAN SINGH SHARMA, SHIKSHA PRASAR SAMITI, NEAR GAUSHALA, MAHAVERRPURA, A.B. ROAD, GUNA, MADHYA PRADESH (APW01565/223252) (B.ED)

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the Committee observed as under:

- (i) The matter was last placed in 304<sup>th</sup> meeting of WRC held on 2-4 April 2019 vide which Committee decided to withdraw the recognition of the institution, accordingly, withdrawal order was issued on 11.04.2019.
- (ii) The institution has filed W.P. (C) 6286/2019 in the Hon'ble High Court of Delhi at New Delhi. The Hon'ble Court passed an order dated 27.04.2023 vide which the withdrawal order dated 11.04.2019 was set aside and WRC was directed to issue necessary restoration order. The Hon'ble Court also granted liberty to the NCTE to re-inspect the petitioner's institution and point out the deficiencies and take appropriate action in accordance with law.
- (iii) Accordingly, restoration order was issued dated 01.06.2023.
- (iv) The Committee considered the matter and observed that in response to SCN dated 16.11.2018, reply vide letter dated 13.12.2018 submitted by the institution received on 17.12.2018 by which the institution is still deficient on the following grounds:
  - The institution has not submitted a letter granting approval for the selection or appointment of the faculties, issued by the affiliating body.



- Original approved faculty list in the NCTE prescribed proforma is not submitted, instead scanned copy of list comprising 1 principal + 15 faculty countersigned by Director, College Department Counsil, Jiwaji University, Gwalior (as per seal reflected on faculty list) is submitted. Date of joining and subject of teaching of faculties not reflected therein. Ph.D certificate of Principal/faculties appointed after 09.06.2017 with experience certificate of principal need to be attached.
- The documents regarding following of prescribed laid down procedure by duly constituted selection committee with recommendation of the affiliating body for selection and appointment of teaching staff not submitted.
- Submitted Building completion certificate is not in accordance with NCTE prescribed proforma, signature of certifying authority (engineer) is not legible.
- The submitted approved faculty list is not displayed in the institutional website. Being recognized by WRC, NCTE, the institution has not developed, maintained, and uploaded/updated all related information on its official website (www.iitscollege.in) considering Clause 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014 as amended time to time.

In view of the above, the Committee decided that Show Cause Notice prior to withdrawal of recognition be issued to the institution u/s 17(1) of the NCTE Act on the above-mentioned points. The institution shall submit a reply accompanied by an original affidavit within 15 days from the date of issue of show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of show cause notice be endorsed to the State Government and Affiliating Body.

 AKSHAY ACADEMY COLLEGE, PLOT/KHASRA NO-331/1/10/1/1, 333/4/7, STREET NO-KHASGI KA BAGICHA, VILLAGE-NANOD, POST OFFICE-INDORE, TEHSIL-INDORE, DISTRICT-INDORE, MADHYA PRADESH-452006 (APP-2664-B.ED & APP-2987-D.EL.ED)

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, and in continuation of decision recorded in the minutes of 380th meeting of WRC held on 10<sup>th</sup> February 2023, the Committee observed as under:

- Show cause notice was issued to the institution dated 11.03.2023 and reply was received in WRC on 06.04.2023.
- (ii) The Committee considered the documents submitted along with the reply and found that the institution is still deficient on the following grounds:
  - Structural Stability/Structural Soundness Certificate of the institutional building for proposed shifting has been issued by Civil & Structural Consultant, Chartered Engineer dated 30.10.2020, which is not issued by concerned State Govt. authority.
  - Regarding Fire safety certificate, a copy of digital Provisional Fire NOC dated 23.02.2022 issued by Pavan Jain on dated 24.02.2022 (Indore Collector/Fire Officer, Indore Division, M.P. submitted by institution. The validity of the fire safety certificate was for one year i.e. up to 22.02.2023. The name of applicant mentioned therein "Akshay Academy College" whereas NOC has been issued to "Akshay Academy Society". A copy of the tax invoice dated 08.02.2023 in connection with purchase of new fire extinguishers in the name of Indore International College is attached. The name does not match with the actual name of institution "Akshay Academy College".
  - As reflected in shifting application, mutation order dated 07.06.2019 and Building Completion Certificate, the location of Land at Survey bearing No.423/2/2, whereas in the submitted building

plan, the land khasra bearing No.423/2/3 is reflected. Both survey and khasra nos. of land seem to be different.

- The name of the institution for which the building plan submitted is not mentioned therein.
- Date of approval of Engineer, R.E.S., Sanwer District, Indore, MP and Sarpanch is not reflected in Building plan.
- Total Built up area 4812.94 sq.mts. mentioned in the submitted Building completion certificate earlier with shifting application, whereas in the latest B.C.C, total built up area 4742.688 sq. mts. mentioned. Out of the total built up area, earmarked built up area for each B.Ed. and D.El.Ed. course has not been separately reflected in the B.C.C.
- Date of approval of Engineer, R.E.S., Sanwer District, Indore, MP and Sarpanch is not reflected in the latest submitted B.C.C.
- From the observation of WRC that from the latitude and longitude and photos of building during online inspection, it appears to be at same building location for two different institutions (Akshay Academy College and Cambridge International College). The explanation submitted by the institution regarding this point is not satisfactory.

In view of the above, the Committee decided that the final Show Cause Notice prior to rejection of shifting application be issued to the institution on the above-mentioned points. The institution shall submit a reply accompanied by an original affidavit within 7 days from the date of issue of final show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of final show cause notice be endorsed to the State Government and Affiliating Body.

 CAMBRIDGE INTERNATIONAL COLLEGE, VILLAGE-NANOD, STREET/ROAD-KILA ROAD, TALUKA/MANDAL-INDORE, TOWN/CITY-NANOD, DISTRICT-INDORE, MADHYA PRADESH-452001 (WRCAPP201660061) (B.ED & D.EL.ED)

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, and in continuation of decision recorded in the minutes of 380th meeting of WRC held on 10<sup>th</sup> February 2023, the Committee observed as under:

- (i) Show cause notice was issued to the institution dated 11.03.2023, which was returned undelivered.
- (ii) The institution vide its representation dated 12.05.2023 followed by email dated 13.05.2023 has requested WRC NCTE to postpone its application for shifting of premises attaching certain documents pertaining to resolution of the management and other documents related to infrastructure. In the letter, it has mentioned that the institution proposes to be established as one of the departments in its proposed university in Mandsaur district of Garoth Tehsil for which 25 acres of land has been purchased.

In view of the above, the Committee decided to reject shifting application of the institution as there is no provision for postponement of pending shifting applications. The institution may submit a fresh application of shifting as per extant NCTE norms and regulations. The institution be informed accordingly.

#### CHHATRA PATI SHIVAJI B.ED. COLLEGE, DEHRA KANPURA VAYA SAMOD, CHOMU, JAIPUR, RAJASTHAN (RJ-1947) (B.ED)

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, and in continuation of

decision recorded in the minutes of 316<sup>th</sup> meeting of WRC held on 27<sup>th</sup> to 28<sup>th</sup> August & 4<sup>th</sup> September, 2020 and accordingly show cause notice u/s 17 was issued to the institution dated 02.11.2020, the Committee observed as under:

 The institution has failed to submit a reply to show cause notice dated 02.11.2020, hence deficiencies pointed out therein are persisting.

In view of the above, the Committee decided that Show Cause Notice under Section 17(1) of the NCTE Act, 1993 prior to withdrawal of recognition be issued to the institution on the above-mentioned points. The institution shall submit a reply accompanied by an original affidavit within 15 days from the date of issue of show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of show cause notice be endorsed to the State Government and Affiliating Body. While issuing the fresh show cause notice to the institution, a copy of the previous SCN dated 02.11.2020 will be enclosed therein.

#### The Committee further observed as under:

(i) The Hon'ble High Court of Rajasthan at Jaipur has passed an order dated 07.02.2023 in W.P.No.14436/2022. NCTE through RD, WRC was impleaded as Respondent No.6 in the matter. The Hon'ble Court has directed Respondent No.6 i.e., RD, WRC to look into the complaint/application submitted by the petitioner and decide the same after providing an opportunity of hearing to all the affected parties by a reasoned and speaking order. It is further observed by the Committee that complaints/ applications of the petitioners in the above-mentioned matter are not readily traceable.

In view of the above, the Committee decided that the petitioners/ complainants shall be asked to submit a copy of their previous complaints for taking an appropriate decision in the matter.

(i) The institution applied for shifting of premises on 07.03.2022 along with certain documents.

The Committee considered the documents and observed that the institution is deficient on the following:

- NOC from both the affiliating bodies (for B.Ed. and D.El.Ed. course) not submitted.
- NOC from the State Govt. not submitted.
- · Building completion certificate not submitted.
- Certified copy of the original registered land document submitted in the name of A.P.S. Shiksha Prasar Samiti and granted recognition for B.Ed. and D.EI.Ed. in the name of APS Mahavidyalaya. Considering provisions under Clause 8(4)(iii) of NCTE Regulations, 2014, the title of land and building is required to transferred in the name of institution by the society.
- Copy of NEC dated 06.01.2022 submitted is not notarized.
- Blueprint of building plan approved by competent Govt. engineer not submitted, instead submitted photocopy of building plan reflecting total carpet area 2577.46 sq.mts. total built up area 4255.02



sq.mts. For both B.Ed.-100 intake and D.EI.Ed.-50 intake, total area is found less considering NCTE Regulations, 2014.

- The name of society mentioned in the CLU dated 03.07.2009 is Maa Hinglaj Shiksha Vikas Samiti (not notarized) which does not match with the trust/society (A.P.S. Shiksha Prasar Samiti) as per initial application.
- Scanned copy of fire safety certificate dated 16.03.2013 (without notarized) submitted is signed by Sarpanch, Gram Panchayat, Jharkheda which is not issued by the competent Govt. fire department.
- Disabled free certificate issued by competent govt. authority not submitted.

In view of the above, the Committee decided to withdraw recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order with a copy endorsed to State Govt., Affiliating Body and others concerned. A copy of the withdrawal order will be uploaded on the NCTE web portal.

#### SARASWATI SHIKSHA MAHAVIDYALAYA, SUBHAS NAGAR, AMBIKAPUR, SARGUJA, CHHATTISGARH (APW04448/723109) (B.ED)

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and in continuation of decision recorded in the minutes of 255<sup>th</sup> meeting of WRC held on 22-24 June 2016, the Committee observed as under:

- As per the decision in 255<sup>th</sup> meeting, show cause notice was issued to the institution on 16.08.2016.
- (ii) The institution submitted a reply to a letter dated 29.08.2016.
- (iii) Vide letter dated 20.03.2023, the institution has requested to change the affiliating body as Sant Gahira Guru University, Ambikapur, Chhattisgarh w.e.f. 2009-2010 instead of Guru Ghasidas University, Bilaspur, Chhattisgarh, wherein a copy each of the Notification dated 02.09.2008 issued by Govt. of Chhattisgarh for change of jurisdiction regarding grant of affiliation by Sarguja University and copy of Order dated 04.10.2018 issued by Govt. of Chhattisgarh regarding change of name Sarguja University to Sant Gahira Guru University is attached.
- (iv) After perusal of reply of the institution dated 29.08.2016, the institution is still deficient on the following grounds:
  - The Building Completion Certificate issued is by a Private Engineer. Address of location not provided.
  - Notarized CLU (certificate of land) is not submitted.
  - Photocopy of Building Plan not approved by Govt Authority
  - Notarized NEC (Non-Encumbrance certificate) is not submitted.
  - Photocopy of Certified Land Documents signed by Sub-Registrar, Ambikapur submitted, however, legible certified/Notarised copy is required.
  - M.Ed/PG marks in respect of faculty Dr. Chhabi rani Mandal, (Principal) is 54.80% M.Ed, Rani Rajak-M.A. (Hindi)52.08% (PG), Smt. Priyalata Jaiswal M.A (English)53.10%, Ram Chandra Rajwade M.A. (G) 50.02%, Avadesh Yadav M.A. (Hindi)-51.00% and faculty S.No.5-8 marks are not readable, and most of the columns are blank-without photographs of the staff & teaching subjects are not mentioned and not approved by the Registrar of the concerned university/affiliating body. No Staff Profile and documents are submitted.

In view of the above, the Committee decided as under:

- The change of affiliating body from Guru Ghasidas University, Bilaspur, Chhattisgarh to Sant Gahira Guru University, Ambikapur, Chhattisgarh (formerly Sarguja University) be permitted as per Govt. Notification dated 02.09.2008 and dated 04.10.2018 respectively.
- Final Show Cause Notice prior to withdrawal of recognition be issued to the institution u/s 17(1) of the NCTE Act on the above-mentioned points. The institution shall submit a reply

accompanied by an original affidavit within 7 days from the date of issue of final show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of final show cause notice be endorsed to the State Government and Affiliating Body.

 MAHARASHTRA COSMOPOLITAN EDUCATION SOCIETY, 2390, K.B. HIDAYATULLAH ROAD, AZAM CAMPUS, PUNE CAMP, PUNE-411001, MAHARASHTRA (APW00744/123092) (B.A.B.ED.-INTEGRATED)

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, the Committee observed as under:

(i) The institution vide letter dated 24.01.2023 received in WRC on 10.02.2023 has requested seeking permission for change of Affiliating University/Examining Body enclosing certain documents.

In view of the above, the Committee decided that change of affiliating body be permitted in respect of following institutions under the same society recognized by WRC NCTE from "University of Pune" to its newly established University viz. "Dr. P.A. Inamdar University, Pune":

The original file of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and in continuation of decision recorded in the minutes of 255<sup>th</sup> meeting of WRC held on 22-24 June 2016 the Committee observed as under:

- As per the decision in 255<sup>th</sup> meeting show cause notice was issued to the institution on 17.03.2017.
- (ii) Institution submitted reply vide letter dated 10.04.2017 received in WRC on 17.04.2017.
- (iii) Institution vide letter dated 25.06.2019 received in WRC on 28.06.2019 & another letter dated 25.06.2019 received in WRC on 11.07.2019 has requested for closure of B.Ed. Course along with certain documents.
- (iv) Vide letter dated 29.07.2019 (received on 31.07.2019), the institution informed for withdrawal of its previous letter for closure of B.Ed. programme enclosing the resolution dated 12.07.2019 of

the trust for continuance of programme and mentioning that they will be taking admissions for the academic year 2019-2020.

- (v) The institution vide letter dated 07.12.2022 (received on 27.12.2022), 16.12.2022 (received on 09.02.2023) & 24.02.2023 (received on 22.03.2023) intimated that for intake capacity of their college, infrastructure and staff is only 50 students i.e. one unit and requested in its last covering letter dated 24.02.2023 to issue letter for one unit of 50 students for the academic year 2021-22 (onwards).
- (vi) The institution is still deficient on the following grounds:
  - In response to last SCN issued dated 17.03.2017, reply vide letter dated 10.04.2017 and as per all correspondences made with WRC mentioned above (including last letter dated 24.02.2023), the institution failed to submit approved faculty list as per prescribed qualification under NCTE Regulation, 2014 as amended time to time in accordance with NCTE prescribed proforma.
  - The photocopy of staff list submitted by the management also falls short of the requirement of 01 Principal + 07 faculty for an intake of one unit 50 students for B.Ed. course, even though it has been granted recognition for two units 100 students of B.Ed. course. As per faculty list (academic year:2022-23) the distribution of faculties across different curricular areas for one unit (50 students) of B.Ed. course is not followed as per the norms and standards (Appendix-4) under NCTE Regulation, 2014.
  - The institution has failed to comply with the second deficiency of SCN issued dated 17.03.2017 "originally notarized Change of Land Use/Non-encumbrance Certificate/Building Plan and Building Completion Certificate".
  - The institutional website (www.tscermumbai.in) is not maintained and updated by uploading all relevant information considering Clause 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014 as amended time to time.

In view of the above the committee decided as under:

- Reduction of B.Ed. intake from 100 (two units) to 50 (one unit) be permitted from the date of issue of the latter with a copy endorsed to the State Government and Affiliating Body and others concerned and the same shall be uploaded on the NCTE web portal.
- 2. In view of the above, the Committee decided that the final Show Cause Notice under section 17(1) of the NCTE Act, 1993 prior to withdrawal of recognition be issued to the institution on the above-mentioned points. The institution shall submit a reply accompanied by an original affidavit within 7 days from the date of issue of final show cause notice failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations. A copy of final show cause notice be endorsed to the State Government and Affiliating Body.
