As per Clause 8(4) of NCTE Regulations, 2014 as amended from time to time, which stipulates that *“No institution shall be granted recognition under these regulations unless the institution or society sponsoring the institution is in possession of required land on the date of application. The land free from all encumbrances could be either on ownership basis or on lease form Government or Government institutions for a period of not less than thirty years. In cases where under relevant State or Union territory laws the maximum permissible lease period is less than thirty years, the State Government of Union territory administration law shall prevail and in any case no building shall be taken on lease for running any teacher training programme.”*

- (i) The institution is conducting degree courses i.e. B.A. with intake 300, B.Sc. with intake 300 (Biotechnology, Microbiology, Computer Science), MA with intake 75 (English, Hindi, Political Science), BCA with intake 60, M.Sc. with intake 125 (Math, Chem, Zoology, Biotechnology, Computer Science), B.Com. with intake 300, M.Com. with intake 80 (Taxation, Management), BA LLB with intake 60, LLB with intake 60 combined intake of 1360. The sufficiency of land and built-up area for 1360 intake of multidisciplinary courses and 100 intake for B.Ed. course cannot be ascertained.
- (ii) Land in the name of Bharat Heavy Electricals Limited, Bhopal uploaded by the institution. The institution has uploaded letter dated 22.02.2025 issued by Senior Engineer, BHEL stating that:  
*“it is hereby clarified that a plot of land admeasuring 19 acres i.e. 827640 sq.
