Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.

- 11. The University is required to submit copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly field Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014.
- 12. The University is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.

Decision of WRC:

The application of the institution along with other related documents was carefully examined in the light of the NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided as under:

The institution is still deficient on the following grounds:

- 1. First Show Cause Notice after restoration order dated 23.08.2021 was issued on the following grounds:
- a) Initial recognition was granted to B.Ed. course of one year dated 21.04.2005. For non-submission of affidavit, revised order for B.Ed. course of two years was not issued.
- b) In the matter of compliance of revised recognition in light of NCTE Regulations, 2014, 1st Show cause notice issued dated 13.08.2020 followed by 2nd show cause notice dated 28.09.2020. No reply received.
- c) Recognition to B.Ed. course was withdrawn vide order dated 10.12.2020.
- d) Matter was remanded back by NCTE Appellate Authority vide order dated 15.02.2021.
- e) Restoration order was issued dated 23.08.2021 clearly mentioning that the institution shall continuously adhere the NCTE Regulations, 2014 as amended time to time.
- f) The institution has not submitted compliance regarding fulfilment of grounds mentioned on appeal remand back order dated 15.02.2021
- g) The institution has not adhered to the laid down conditions of NCTE Regulations, 2014 for which revised order has not been issued. The institution is still deficient even after issuance of restoration order 23.08.2021.
- h) The institution has not shifted in its own premises till date.
- i) The institution has also not submitted Performance Appraisal Report (PAR) for the academic session 2020-2021.
- 2. Final Show Cause Notice issued dated 07.01.2023 under section 17(1) on the grounds mentioned therein.
- 3. Without complying deficiencies, the institution submitted application for shifting of premises vide letter dated 14.03.2024.
- 4. The matter was re-examined in the 406th meeting of WRC, wherein committee decided that institution is required to submit following documents within 21 days along with affidavit by the authorized representative of the management:

- (i) The institution is required to submit Certified registered land documents issued by the Registering Authority.
- (ii) The institution is required to submit Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.
- (iii) The institution is required to submit CLU (Change of Land Use) Certificate after conversion to use land from agriculture to educational purpose issued by the Competent Government Authority.
- (iv) The institution is required to submit Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- (v) The institution is required to submit Certified copy of site plan with demarcated land area for running different courses.
- (vi) The institution is required to submit Building safety certificate from the Competent Government Authority.
- (vii) The institution is required to submit Fire safety certificate issued by the Competent Government Authority.
- (viii) The institution is required to submit Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- (ix) The institution is required to submit Building Completion Certificate signed by the Competent Government Authority.
- (x) The institution is required to submit latest/current faculty list approved & signed each page by concerned Registrar of affiliating body in original with the details of their teaching subject, date of birth, date of selection/appointment, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GoI dated 09.06.2017), salary structure and related documents duly attested by authorized representative of management along with copy of approval letter of affiliating body.
- (xi) Notarized original affidavit on Rs.100/- on non-judicial stamp paper by the management and Rs.10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.
- (xii) The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.
- (xiii) The institution is required to submit copies of valid Fixed Deposit Receipts issued by Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, WRC, NCTE & Management along with duly filled Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014.
- (xiv) The institution is required to submit compliance of all points in light of Clause 7(14)(i), 8(6), 8(14) and 10(3) of NCTE Regulations, 2014 as amended from time to time.

Accordingly, the above decision was communicated to the institution vide letter dated 10.09.2024 with direction to submit reply within 21 days along with affidavit by the management.

- 5. The WRC issued Final opportunity specifying the deficiencies vide letter dated 29.10.2024 on the following:
 - a) Show Cause Notice u/s 17 NCTE Act, 1993 was decided in the 371st meeting of WRC held on 21st -22nd September 2022 as recorded in the minutes of the said meeting to submit their reply on the basis of uploaded minutes on the website.

b) Final Show Cause Notice u/s 17 of NCTE Act, 1993 was issued vide letter No. NCTE/WRC/323091/B.Ed./377/GJ/2022/ 221975 to 221976 dated 07.01.2023, which was not replied by the institution so far and the same was incorporated in the latest communication letter vide No.NCTE/WRC/APW00225 /323091/B.Ed./377/ GJ/2024/ 225507-08 dated 29.10.2024 decided in the 406th Meeting of WRC held on 24th -26th July, 2024 reply of which has not been furnished. The deficiencies mentioned in the aforesaid FSCN are still persisting and the same needs to be complied with.

c) In pursuance of decision of WRC communicated vide letter dated 10.09.2024, the institution submitted reply vide letter dated 05.09.2024 (based on the minutes uploaded on website) in the matter of application for shifting of premises, the institution is still deficient on the following:
(a) As per submitted registered land document, total land area is 2500 sq.mts, which is less than required 3000 sq mtr. under the provisions of NCTE norms.

(b) Photocopy of unapproved building plan is submitted. The institution is required to submit blue print of approved Building Plan signed by the Competent Govt. Authority/Engineer indicating the name of the course, name and address of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.

(c) As per submitted Change of Land Use Certificate, total land area mentioned as 2500 sq.mts, which is less than required 3000 sq mtr. under the provisions of NCTE norms.

(d) Site plan of institution approved by competent Govt. authority is not submitted.

- (e) Submitted Building Safety Certificate is not issued by competent Govt. authority.
- (f) Disable friendly certificate has not been issued by competent Govt. authority.

(g) Building completion certificate is not submitted in NCTE prescribed proforma.

(h) Faculty list is not approved by the Registrar of the concerned affiliating body/university.

(i) As per information provided by the institution, it is not running since last 2 years, hence they are unable to furnish salary details of the teaching/non-teaching staff.

(j) From the unapproved faculty list, 02 Nos. of pedagogy faculties are less as per norms.

(k) Documentary evidences in support of selection procedure for appointment of Principal/faculties are not submitted.

(l) Existing affiliation letter issued by the concerned affiliating body/university is required to be attached because the institution was not running since last 2 years.

6. Reply submitted vide letter dated 24.09.2024 and 03.10.2024 by the institution followed by letter dated 04.11.2024 was examined. However, the institution has not yet submitted any relevant documents in this regard and institution is still deficient on the following:

- a) One each teaching faculty not appointed for pedagogy subjects of Math, Science and Social Science as per Clause-5 of Appendix-4 of NCTE Regulation, 2014 (Amended from time to time as well as provisions in GOI No. 177 dtd. 09.06.2017).
- b) 2 Years salaries details of teaching/non-teaching staff are not submitted.
- c) Faculties are approved by the Registrar of Veer Narmad South Gujarat University, Gujrat on 22.05.2023, which is not currently approved, and approval letter are also not submitted.
- d) Land area shown 2500 Sq. mts. instead of 3000 Sq. mts. In Land Building Lease Agreement; Approved Building Plan; Land Use Certificate; Disable Friendly Certificate (which is not issued by the competent authority); Total land Area is not mentioned in Building Completion Certificate; and 2 years affiliation letters/orders issued by affiliating body are not submitted; Affidavit dtd. 06.01.2015 is submitted by Trustee of Parth Education and Charitable Trust vide letter dtd. 26.11.2024, but proof of submission of this affidavit at that time is not attached

therewith and it is not acceptable without signed by President/Secretary of the Trust of institution.

Therefore, the Committee decided recognition of the institution for B.Ed. course is withdrawn under Section 17(1) of NCTE Act 1993 with copy to all concerned.

Further, the Committee decided that application for shifting of premises cannot be considered.
