					<p>Total ..4000 sq mts.</p> <p>4.2. B.Ed-AI (1 unit) will require another 500 sq mts.</p> <p>5.1. As against this total requirement of 4500 sq mts, they have only 4162.50 sq mts as per the latest VT Inspection Report and only 3263 sq mts (as per the BCC dated 31.07.13).</p> <p>5.2. The BCC is very old. They should be asked to file a new BP and a new BCC duly approved by the Competent authority.</p> <p>5.3. Based on available information about built up area, we had taken a unilateral decision to reduce the B.Ed intake strength from 2 units to 1 unit. The applicant had not made any request for such reduction. Fortunately, no formal order was issued in this regard. Our decision in reference may, therefore, be ignored as infructuous .</p> <p>6.1. They should also clearly explain the built-up area position. Either it should be augmented to accommodate all the courses in reference or, they should indicate which courses they wish to retain and which they wish to wind up.</p> <p>6.2.
