Built up area and earmarking for each course (if running 2 or more course) not reflected. (iii) LUC – The institution has submitted photocopy of LUC mentioning Sy No. 309/1, 309/2, 320/8 and 309/2. (iv) BCC – The institution has submitted notarized copy of BCC which is not in proper Govt. format. The Sy. No. 309/1B, 1C, 1D, mentioned in BCC does not reflect in the LUC. (v) The BCC, BP and FDRs are all in the name of International College of Education. However, the recognition order and RPRO has been issued in the name of International College of Education (Women). - (i) The SRC while going through the matters pertaining to Tamilnadu particularly the staff list which is to be approved by the affiliating University i.e. Tamilnadu Teacher Education University, Chennai, it is observed that in some of the cases they approved the list with several conditions. It is, therefore, decided to request the Registrar, Tamilnadu Education University to approve the list of faculty of any institution in their jurisdiction area only when the institution appoint faculty members with the qualifications and other specifications included in the norms & standards prescribed by the NCTE for each teacher education programme. Accordingly directed the SRO to write a letter to the Registrar, TNTEU.

The meeting ended with a vote of thanks to the Chair.
