Further, it was brought to the notice of Committee that Show-cause Notices were issued to certain institutions as per the decision taken in 281 st meeting of NRC dated 20 th to 21 st February, 2018. The Committee decided that follow up action be taken accordingly as per NCTE Act and Regulations, 2014. Chairman, NRC also desired that the updated status of pending cases including MRM report be placed in the next meeting.	Further, it was brought to the notice of Committee that Show-cause Notices were issued to certain institutions as per the decision taken in 281 st meeting of NRC dated 20 th to 21 st February, 2018. The Committee decided that follow up action be taken accordingly as per NCTE Act and Regulations, 2014. After examining the relevant documents in the original file of the concerned institution regarding first SCN issued to it and reply of first SCN has not been submitted. Chairman, NRC also desired that the updated status of pending cases including MRM report be placed in the next meeting.

It was further brought to the notice of the committee that the letter/SCNs issued by NRC office are being returned undelivered which indicates that the TEIs/Societies/Trust are not maintaining their addresses properly. The committee took a serious note about the complaints being received from various states against the institutions and decided that all such complaints be processed as per CVC guidelines and if the allegations are proved then such cases be put before the committee for further action.

The committee decided that a public notice be issued at the level of RD, NRC (after the approval of Chairman, NRC) addressing the major concerns like returning of undelivered letters, complaints etc. and the institutions may be directed to maintain the proper address/contact details and their websites also.

The state of Rajasthan has put a ban on shifting of premises of TEIs (from the session 2018-19) from one tehsil to the other. All such applications received be processed accordingly.

With the permission of the Chair, the agenda was placed before the Committee members alongwith the office records. The Committee after going through the reports/documents took the following decisions.


