The Hon'ble High Court of Delhi vide order dated 23.12.2020 has ordered to petitioner as follows: <i>"The petitioner will also on affidavit undertake to remove all deficiencies pointed out in the second show cause notice dated 26.03.2019. Subject to filing of the affidavit within one week from today, the petitioner is allowed to participate in the counselling for the academic session 2020-21".</i> 2. Further, the Hon'ble High Court of Delhi vide order dated 23.08.2021 ordered as follows: <i>"The interim order dated 23.12.2020 will continue for the academic year 2021-22 also, subject to compliance with the conditions stipulated in the said order".</i> 3. The Committee found that the institution has not submitted the compliance till date in response to the Hon'ble High Court order dated 23.08.2021 wherein petitioner was directed remove all deficiencies pointed out in the second show cause notice dated 26.03.2019. <p>Keeping in view of the above, the Committee decided that the institution can not be permitted to participate in the counselling for the academic session 2021-22.</p>
15.	<p>Court matter wherein Appeal/Review to be filed Shivom College of Education, Ambika College of Education,</p>	<p>Around 1.5 months before the NRC had decided to file an Appeal/Review before the Hon'ble High Court against the orders passed by the Hon'ble High Court in the reference cases and the matters were referred to the Legal Section of the NCTE Hqrs for filing an Appeal.</p> <p>Further, Mr. Ravinder Singh, US (Legal) was called in the NRC's last meeting which was held on 27.10.2021 for discussion and he has assured that the appeal will be filed very soon.</p> <p>It has been reported that the said Appeal has not been filed till date and the stipulated time of 60 days for filing of appeal is going to be expired.</p> <p>In view of the above, the Committee decided that the matter may be brought to the notice of the Chairperson, NCTE and Member Secretary, NCTE to intervene in the matter.</p>
