- NRC had already initiated part compliance of the order to the extent, that relates to the processing of the application of the petitioner.
- 2. Mr. Akshay Chandra was neither instructed nor authorized by the NCTE/NRC make suggestions/ submission regarding public notice in this matter. He at his own will had submitted and got his statement recorded before the . Hon'ble Court without seeking adequate instructions. the matter was listed for the first time and an effective hearing took place which disposed it off with such serious implications and prejudice to NCTE.
- 3. It is noteworthy, that the directions with respect to publish public notice was never prayed as part of the petition memo by the petitioner. The Hon'ble High Court has accommodated the petitioner above and beyond what he has prayed for.
- 4. NCTE HQs is requested to please terminate the services provided by Mr. Akshay Chandra to NRC with immediate effect.
- 5. As per the decision taken by the committee, a Review petition may be filed before the Hon'ble High Court of Delhi pronto.
