The public notice dated 02.01.2020 was placed before the committee and the committee appreciated it. Further, the committee opined that the details of the TEIs complying the notice are to be placed before the committee in its next meeting and proceedings must be initiated against those not complying with the said public notice.




The minutes of the 288<sup>th</sup> & 289<sup>th</sup> meeting of NRC were placed before the committee and it was highlighted that the decision to constitute VT is already taken by the NRC in a number of cases however the VT could not be constituted. The committee decided to reiterate the same decision of constitution of VT and take the necessary action on case to case basis. The details shall be placed before the committee in the next meeting.

The committee also opined that the letters may be written to the state government seeking the details of their policies in terms of recognition of TEIs and the programmes/courses. **It was also brought to the notice of the committee that the decision taken in the meeting are placed in the public domain in the form of minutes which are indicative in nature and being challenged by the TEIs at various forums. Therefore, the committee decided that the practice will continue and the RD, NRC is authorized to issue the detailed letters/orders based on the facts/records.**
