The NRC noted that the powers are vested to NRC under Clause- 8 (12) of NCTE Regulations, 2014, which states as under: -

8 (12) The institution shall make the information or documents available to the Council or its authorised representatives as and when required by them and failure to produce or show any of the required documents, shall be treated as a breach of conditions of recognition.

In view of the powers vested with NRC under Clause 8 (11) & 8 (12) of NCTE Regulations, 2014. The NRC decided that a notification be uploaded on the website of NRC, NCTE directing to all TEIs running the B.Ed, M.Ed and B.P.Ed courses in 2014 to submit the compliance of the Revised Recognition order within 15 days of the uploading of Notification on website with documentary evidence. The institutions be directed to submit the compliance of Regulations, 2014 as under:




