				The matter was deferred with the direction to the then RD to examine the file of institution in depth and put the report in next meeting of NRC. The file was put up again in 313 meeting of NRC during meeting the then RD reported that While examining in the matter it came in the knowledge that near about 1000 institutions has been granted recognition through single order No. File No. NRC/NCTE/Recognition/ for B.Ed./ D.El.Ed. courses in 252nd meeting

held on 19 th April to 02 nd May.2016. (2 May was the deadline (last date) for sanction of session 2016-17 for admission of students in B.Ed. D.El.Ed. courses)
Committee decided in 313 meeting that the matter be dealt separately.
Hence, the Committee decided to direct the RD. NRC to examine the matter in detail and put factual report state wise and course wise, about the No. of TEIs got recognition.in 250 and 252 meeting and besides at least 10 files (Randomly seleted0) should be put up before the Committee in ensuing meeting, after scrutiny.

- The Committee unanimously decided that the old dak pending in this office without action
 be kept in the concerned file and seek current replies from the concerned institutions in
 respect of them and after receipt of the reply, the same will be placed before the committee
 for decision thereon individually.
- NCTE GOI Notification No. 1307 dated 13.05.2020 in respect of retrospective permission to the Central/State government universities /institutions for various Teacher Training courses is appraised to the Committee and Committee noted the GOI notification.
- It came in the knowledge of the Committee that there may be some TEIs who may be working-- (1) without valid recognition order or\ and (2) even after withdrawal of recognition order by NRC.

this type of TEIs may have negative effect on the future of students admitted in these TEIs because degrees of the students studying in such institution may not be verified by NCTE. Therefore, the Committee unanimously decided to direct RD that:

- (1) The State wise list of recognised TEIs should be uploaded on website of NRC stating their courses and intake:
- (2) The list of TEIs whose recognition has been withdrawn should also be uploaded on NRC WEB separately indicating the session of withdrawal;
- (3) A request letter should be sent to all concern department of STATE/UT Govts for getting the list of TEIs working in their jurisdiction having details of courses and intake;
- (4) A letter should also be written to all Universities working in NRC jurisdiction requesting them to send the list of TEIs affiliated by them together with courses and intake.

The meeting ended with vote of thanks to the Chair.
