

- 4. The Appeal order dated 15.12.2020 was put up before the committee on 9th April, 2021 in the 334th meeting i.e. elapsing of around 3.5 months. In this meeting the committee decided as under:

"The Committee decided that the decision taken to withdrawal of the recognition vide letter dated 10.07.2020 from the session 2021-22 stands. Hence, a letter be issued to the institution and other concerned i.e. University, State Government etc. accordingly.

5. The decision of the 334 meeting was not properly conveyed to the institution. writing confusing statement in the last which is as follows:

"The Committee decided that the decision taken to withdrawal of the recognition vide letter dated 10.07.2020 from the session 2021-22 stands. Hence, a letter be issued to the institution and other
