



The NRC in its 312<sup>th</sup> meeting held on 14<sup>th</sup> February, 2020 has decided to withdraw the recognition of institution.</li> <li>2. the decision of the NRC was conveyed to the institution vide order dated 10.07.2020 i.e after elapsing of around 5 months.</li> <li>3. The withdrawal was remanded back to NRC by the Appeal Committee vide its order dated 15.12.2020.</li> <li>4. The Appeal order dated 15.12.2020 was put up before the committee on 9<sup>th</sup> April, 2021 in the 334<sup>th</sup> meeting i.e. elapsing of around 3.5 months. It seems The institution was deliberately given a chance to move the matter in the Ho’ble Court by providing 15 days time for submission of written request/report which was not decided by the NRC.</p> <p>7.
