	<p>University vide letter dated 24.1.2020 has categorically accepted about the insufficient number of the faculty members and not getting DEB, UGC approval for their Self-Instructional material.</p> <p>As the University, failed to fulfill the conditions stipulated in the NCTE Regulations, 2014, the Committee therefore, decided to withdraw the application of the University for running B.Ed. (ODL) programme.</p> <p>Hence, the Committee decided to withdraw the recognition to Mother Theresa Women's University, Anandagiri 4th Street, Kodaikanal Village and Post, Kodaikanal Taluk and City, Dindigul District, Pin - 624101, Tamilnadu for conducting B.Ed. Before start of the meeting of the Committee, the SRC resolved the following: -

The Members of the SRC received a written complaint about the institutions which were recognized during 2015-2016 onwards by the SRC, NCTE, the Committee observed that the SRC, NCTE during the said period accorded the recognition for 40 institutions to run B.A.B.Ed./ B.Sc.B.Ed. Integrated programme. The matter of according the recognition liberally to the institutions was investigated by the CBI. In this connection the Vigilance Section of the NCTE HQ. submitted a report to the SRC, NCTE. Taking into consideration, the SRC decided to give notice to these institutions and after having received information from these institutions withdraw the recognition of all these institutions running B.A.B.Ed./B.Sc.B.Ed. Integrated programmes.

However, the institutions who obtained recognition for B.Ed course were not considered for such an exercise.

In view of the complaint received about not adhering the NCTE norms, the Committee decided to write a letter to State Govt. to follow the same practice which they have done for 4 year B.A.B.Ed./B.Sc.B.Ed. Integrated programme may be extended even for B.Ed. colleges permitted after 2015 onwards.

	<p>NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-</p> <p>The Committee perused the representation made by the Registrar of Manomaniam Sundaranar University for according recognition to Pre School Teacher Education Course retrospectively.</p> <p>It is observed from the records that the University started the programme without obtaining recognition from the NCTE. In fact this programme is not notified by the NCTE at any point of time. Still the University wants to run the programme then they might have applied under Innovative Programme. It is clear that the University started the programme at its own as such NCTE has no jurisdiction to consider the request of the University to accord the recognition with retrospective effect. Therefore, prayer be made before the Hon'ble High Court that the University started the course illegally as such the NCTE may not be in a position to accord recognition retrospectively as per its Act.</p> <p>The representations made by the University are not in accordance with NCTE Rules and Regulations as such these requests for consideration of grant of recognition retrospectively for running Pre School Teacher Education Course be refused immediately followed by the intimation to the Hon'ble High Court.</p>
