The built-up area required is 4500 (2000 + 2000 + 500) sq.mts. They have 5600 sq.mts. So, VT Inspection is not required.</li><li>4. Their Faculty List is not acceptable.<ol style="list-style-type: none"><li>i) Out of a list of 1 + 15, only 6 are qualified.</li><li>ii) The other 10, who were recruited after 09.06.2017, when the Regulation was amended to prescribe Ph.D. or NET as essential qualification, do not have either Ph.D. or NET.
