The Committee taken note of the clause 5(3) of NCTE Regulations, 2014 which reads as under:-

"The application shall be submitted online electronically alongwith the processing fee and scanned copies of required documents such as no objection certificate issued by the concerned affiliating body. While submitting the application, it has to be ensured that the application is duly signed by the applicant on every page, including digital signature at appropriate place at the end of application."

The committee observed the following:-

- 1. The University had submitted appalication seeking grant of recognition for B.Sc.B.Ed. and B.A.B.Ed. (4 years integrated programmes) through ofline mode.
- 2. The NCTE had not invited applications seeking grant of recognition for the courses applied for by the University, hence, the application is not liable to be considered.
- 3. The courses i.e. 4-year Integrated programme leading to B.A.B.Ed. and B.Sc.B.Ed. degree has been omitted vide NCTE notification dated 26.10.2021

In view of the above grounds and relevant clauses of NCTE Regulations, 2014, the application of the University seeking grant of recognition for B.Sc.B.Ed. and B.A.B.Ed. courses cannot be considered and processed. Therefore, original file alongwith processing fee submitted by the University be returned.

2. Vamsadhara College of Education, Kotabommali, Srikulam District-532195, Andhra Pradesh.

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The institution vide letter dt. 16.06.2021 submitted documents but are deficient in terms of the following:-

- a. The institution submitted a proforma of 16 faculty signed by the Dean, CDC and Registrar, Dr. B.R. Ambedkar University but the date of approval is not mentioned over it.
- b. The faculty namely N. Venkateshwara Rao is possessing 53% marks in M.Sc. Botany, hence, not eligible for appointment as per Appendix 4 of NCTE Regulations, 2014.
- c. All faculty shown to be appointed in 2009 and 2016, the institution did not submit bank statements of all individual faculty (for last 1 year) showing disbursement of salary through bank account as required to be submitted under clause 10(2) of NCTE Regulations, 2014.
- d. The institution submitted the building plan vide letter dt. 17.01.2020 but the multipurpose hall was not available. Now the latest BCC shows the size of hall as 260.12 sq. mtrs. But the building plan submitted along with the letter dt. 16.06.2021 is not legible.
- e. The institution against the LUC submitted a "Possession and Enjoyment Certificate" dt. 23.06.2007 issued by the Tehsildar but this certificate only certifies that the land has been taken on the lease basis for a period of 30 years and it is in possession of the managing society. This certificate does not establish the purpose of land for education.

Therefore, the Committee decided to issue **Final Show Cause Notice u/s 17 of NCTE Act**, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 21 days from the date of issue of **Final Show Cause Notice**.

The Committee carefully considered the letter dated 08.12.2016 and 23.12.2016 whereby to stop the commercialisation of Teacher Education, the application for change of Management can-not be considered. It is evident from the record submitted by the institution that there is Sale Deed for consideration regarding change of Management/Society.

In view of the above the Committee decided to confirm the Withdrawal order dated 28.06.2021 passed by the SRC.

The Appellate Authority vide order No. 89-341/E-232936/2022 Appeal/1st Meeting, 2022 Appeal No.APPLSRC202114222 dated 31.01.2022and the Council remands back the case. The institution has submitted reply of appeal remand back case vide dated 04.11.2021.
