- 1. The institute after issuance of Final Show Cause Notice dt. 02.02.2022 had submitted an application for shifting of premise. The application proposes to shift the premise on the land taken on the basis of lease Deed dt. 28.08.2017 executed between private dt. 28.08.2017 executed between private parties which is not permissible under clause 8(4) (i) of NCTE Regulations. 2014. Further as per lease deed ground, first and second floor have been taken on lease which belongs to the building constructed on 6.93 Acres of land, accordingly the requirement of open land of 1000 sq. mt. as conversed under clause 6.1 of appendix 4 of NCTE Regulations, 2014 is violated.
- 2. The initial recognition was granted to the institute under the management of Mary Priscila Rural Development Trust, but the Lease Deed is executed between the South India Salesian Society and The Kaktpadi Don Bosco Orphanage Society which is not permissible under NCTE Regulations.
- 3. Other documents such as building plan, BCC, NEC etc., cannot be considered.

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply on 09.02.2022. The Committee observed the reply submitted by the institution and found the following deficiencies.

- 1. The institute after issuance of Final Show Cause Notice dt. 02.02.2022 had submitted an application shifting for of application premise. The proposes to shift the premise on the land taken on the basis of lease Deed dt. 28.08.2017 executed between private dt. 28.08.2017 executed between private parties which is not permissible under clause 8(4) (i) of NCTE Regulations, 2014. Further as per lease deed ground, first and second floor have been taken on lease which belongs to the building constructed on 6.93 Acres of land. accordingly the requirement of open land of 1000 sq. mt. as conversed under clause 6.1 of appendix 4 of NCTE Regulations, 2014 is violated.
- 2. The initial recognition granted to the institute under the management of Mary Priscila Rural Development Trust, but the Lease Deed is executed between South the India Salesian Society and The Kaktpadi Don Bosco Orphanage Society which is not permissible under NCTE Regulations.
- 3. Other documents such as building plan, BCC, NEC etc., cannot be considered.



Hence, the Committee decided to withdraw the recognition granted to Matha College of Teacher Education. Annavasal Road. Vaampuram. Manamaduarai. Sivagangai District, Tamilnadu-630606 for conducting B.Ed. &D.T.Ed. programme with effect from the academic session i.e. 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above

Hence the recognition granted to St. Mary's College of Education, No. 95, Annai Street, Vallimalai Road, Mission Compound, Katpadi Post, Vellore District, Tamilnadu-632007 for B.Ed. course is withdrawn under Section 17(1) of NCTE Act, 1993 from the next academic session i.e. 2022-2023. 

Resolutions:-

- 1. The Southern Regional Committee resolved to advise the RD, SRC to release the FDRs of those colleges who were voluntarily closed down the courses / withdrawn by the NCTE and not approached to the Appellate Authority otherwise. FDRs pertaining to Endowment and Reserve Fund be returned to the institutions. If the Government / affiliating bodies failed to respond to the request of such institutions obtaining NOC within a month's time. Considering that there is no objection either from the government / affiliating bodies the FDRs may be returned to the institutions after obtaining an undertaking.
- The Committee resolved to advise RD, SRC to write a letter to the Registrar, Rayalseema University, Karnool, A.P. to forward the staff list of such institutions offering M.Ed. programme in their jurisdictional area in the prescribed proforma alongwith the bank statement of salary disbursed to the faculty through bank account immediately.
- 3. The Committee resolved to advise RD, SRC, if any institution obtain order from the Hon'ble Court, if it is decided to be implemented, such order should be limited to the particular institution instead of extending the same judgement to all other such similar institution.
- 4. The SRC resolved to advise the RD, SRC to address a letter to Registrars of all affiliating Universities and SCERT Directors (in its jurisdictional area) with the request to follow the adherence of UGC / NCTE Norms in extending affiliation to the teacher educational institutions in their jurisdictional area / state. Further, they may also be requested to involve preferably teacher educators for visiting the TEIs for extending affiliation. RD, SRC is also advised to enclose a copy of NCTE Regulations, 2014 alongwith appendix for D.EI.Ed., B.Ed. and M.Ed. courses alongwith 2017 amendment of NCTE Regulations, 2014. The letter may also be include the clause 10(2) of NCTE Regulations, 2014 regarding disbursement of salary to faculty and non-teaching staff through their bank account.
- 5. The Committee observed that even after writing to the Secretaries of Education of the Sates (falling under the jurisdictional area of SRC) about the discontinuation of Pandit Training Programmes in 2014 Regulations, as still in some states admissions are continuing in Pandit Training Programmes. This will affect the future career opportunities for the students who are
