

Resolutions: -

1. The Southern Regional Committee advised the Regional Director to write a letter to the Secretary Education marking a copy to the Commissioner, School Education and Director, SCERT, Government of Telangana Hyderabad to send the list of colleges offering D.Ed. programme and not obtained affiliation from the SCERT for the last couple of years. The colleges who are not able to make admissions and even where admission are in single digit, such colleges may also be included in the list. This information will enable the SRC, NCTE to serve a notice for withdrawal of the recognition. Otherwise all these institutions are reflecting that they are all functional institutions in the NCTE official data.

A letter in this regard was already sent to the Director, SCERT, Hyderabad but no action. As such the Committee decided to bring it to the notice of the Secretary, Department of Education, Government of Telangana for immediate action on the matter.

2. The Regional Director appraised the Regional Committee about the decision taken by the Hon'ble Chairperson NCTE to cause sudden inspection either



with or without prior information to the institutions in the jurisdictional area to ascertain the ground realities and to ensure quality in teacher education.

The Committee endorsed the decision taken by Hon'ble Chairperson and advise the Regional Director, SRC to work out the modalities for such sudden inspection by the Committee members / experts in teacher education alongwith the Registrar of the affiliating University/body or his/her nominee.

3. The Regional Committee further advise the Southern Regional Director to issue notice to all the government DIETs, Government colleges of teacher education and the University Departments offering B.Ed. and M.Ed. programmes for issuance of continuation of recognition order at the earliest.
4. The Regional Director further apprised the Southern Regional Committee about the institutions who filled the PAR with certain deficiencies. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institutions seeking infrastructural & instructional details along with GIS location etc. If any institution failed to respond to Show Cause Notice for compliance, after completion of given time, the RD, SRC may issue Final Show Cause Notice and place before the Committee for appropriate action.
5. The Committee discussed in detail about the institutions who failed to submit the PAR as advised by the NCTE. The Regional Director, SRC is directed to prepare a list of such institutions in SRC jurisdictional area and serve a Show Cause Notice for failure of submitting the PAR to all such institutions seeking infrastructural & instructional details along with GIS location etc. If any institution failed to respond to Show Cause Notice for compliance, after completion of given time, the RD, SRC may issue Final Show Cause Notice and place before the Committee for appropriate action.
6. The Regional Committee while processing ITEP applications, it is observed that Andhra University, Waltair, Andhra Pradesh applied for ITEP programme from 3 different departments. The Committee deliberated on it and decided to consider the request of the University for only one slot as this notification for ITEP programme was issued only as a pilot project. Therefore, the Regional Director is advised to write to the Registrar, Andhra University which application is to be considered asking the University to withdraw other 2 applications for further processing.
