The Appellate Authority vide order No. 89-247/E-277848/2022 Appeal/11th Meeting, 2022 APPLSRC202214145 dt. 11.01.2023, the Council remands back the case. The institution vide letter dated 02.02.2023 submitted its reply. On examination of the reply Committee decided to send a Final Show Cause Notice to the institution to submit the representation/required documents to the office the Regional Director, SRC.</p> <ol style="list-style-type: none"> 1. The institute had submitted a copy of Lease Deed dt. 20.07.1974 executed between City Improvement Trust, Bangalore and the Managing Society. The Lease Deed was for the period of 30 years which is expired. 2. The building plan submitted by the institute is neither approved by the competent authority nor legible. 3. Faculty of the institute is not approved by the affiliating body. 4. As per the record issued by the Bruhat Bengaluru Mahanagara Palike a School and pre-University College is also being run in the same premise. The institute did not submit the demarcated building plan for all courses and the build up area is also not sufficient to run the school, pre-university College and B.Ed. course. 5. The institute did not submit documents related to its managing society/trust. 6. The institute did not submit the NEC. 7. The institution has submitted photocopy of FDRs which are matured. 

Resolutions passed by the SRC, NCTE: -

1. The Southern Regional Committee (SRC) thoroughly deliberated on the relevant Gazette Notifications issued by the NCTE for introducing the 4 year integrated Teacher Education Programme (ITEP). In this regard the Committee is of the opinion that the teaching faculty prescribed for the programme is exclusively for the Teacher Education component or it also include the content subjects. A clarification in this regard may be obtained from the NCTE Hqs. before issuing the final recognition order (FR).
2. The SRC seized with the process to ensure the compliance of 2014 Regulations by the Universities offering B.Ed. (ODL) for the last two years. In this regard lot of correspondence took place between office of the SRC with NCTE Hqs. and UGC (DEB). However, out of 18 Universities in the jurisdictional area of SRC only two Universities were issued with the continuation of recognition orders. But, these Universities alongwith others when they approached UGC (DEB) they are seeking some clarifications which can be resolved only by way of having a joint meeting with NCTE and UGC (DEB). Hence, it is resolved to request to NCTE Hqs to have a meeting with UGC (DEB) and clarify their doubts if any and facilitate SRC to move forward to complete the exercise of verifying the adherence of NCTE Regulations for B.Ed. (ODL) of 2014 as desired by the NCTE regulations bureau.
3. It is also resolved to the advise the RD SRC, to complete the process of issuing SCN to all the Government and University Education Departments for all the Teacher Education programmes at a time to consider issuance of RPRO in our jurisdictional area. This may be taken up on priority without any further delay.
4. It is further resolved to advise the RD to initiate action against the letter received from the Registrar, Tamil Nadu Teacher Education University (TNTEU), Chennai about the duplication of faculty in many of the TEIs affiliated to their University. The Committee advised the RD to prepare a detailed note on the action taken by the TNTEU on the matter as desired by the SRC earlier and place the same in the ensuing SRC meeting.
