- 4. The lab facility are not sufficient as per NCTE norms
- 5. Institution is required to make ramp provisions in the building.

Therefore, the Committee decided to issue **Show Cause Notice u/s 17 of NCTE Act**, 1993 before withdrawal of the recognition on the grounds mentioned above to the institution. The institution is required to submit the documents within 15 days from the date of issue of **Show Cause Notice**.

Further, VT members also reported that: -

- "1. Though Playground is a mandatory requirement, but it not available in institution.
- 2. No/ramp/lift or special toilet for physically challenged students is made available in the building.
- 3. No fire safety certificate is made available."

The above mentioned deficiencies are mandatory requirements as per Appendix 4 of NCTE (Norms & Procedure) Regulation, 2014.

Regarding qualified faculty, the institution has not provided the same to the VT members as per Report.

Therefore, the legal counsel, SRC is advised to appraise the same to the Hon'ble High Court of Delhi.
