- (i) The SRC resolved that operation of ITEP portal account of the Chairperson, SRC, NCTE on behalf of the SRC, shall be operated by the Regional Director, SRC as per decision taken by the SRC through minutes of the 387th meeting for further necessary action.
- (ii) The SRC discussed the issue of institution offering Teacher Education programmes without obtaining recognition from the NCTE. In this regard, the Regional Director, SRC, NCTE is advised to write a letter to the Secretary, Education, & Director, SCERT of the State / UT in the jurisdiction of Southern Regional Committee to provide the list of such institution in their respective State / UT (if there are any). **This may be treated as most urgent.**
- (iii) The SRC office shall ensure that in the case of issuance of Continuation Order in RPRO/Shifting orders etc. the order should invariably mentioned the address as per the latest Building Completion Certificate with Sy.No./Khasra No./Plot No. etc. submitted by the institution.
- (iv) The Committee also directed the Regional Director, SRC, NCTE to issue SCN/FSCN to all teacher educations institutions under jurisdiction of the SRC, NCTE as per decision taken 381st meeting, placing of all ODL matters etc. as per the advisory informed to RD, SRC during the meeting.

The meeting ended with a vote of thanks to the Chair.
