The institution is required to submit the documents / representation mentioned within 21 days from the date of issue of the letter.</p>

Resolutions:-

- (i) The Committee discussed in detail several representations received from the faculty working in many of the private un-aided institutions in the Southern Region. The Regional Director, SRC is advised to write all the affiliating Universities/bodies to ensure regular payment of salary to the faculty members into their individual bank account which is mandatory as per NCTE Regulations before according affiliation.
- (ii) The Regional Director apprised the Southern Regional Committee about the status of PAR and consequent legal matters pending with the Hon'ble High Courts. The Committee took note of the same.
- (iii) Further the Regional Director apprised the Southern Regional Committee about non-functioning of the institutions website which is mandatory requirement as per NCTE Regulations, 2014. In view of the non-compliance, the Regional Committee advised the Regional Director, SRC to issue Show Cause Notice to all such institutions seeking infrastructure & instructional details along with GIS location at the earliest.
- (iv) The Regional Director placed before the Committee the correspondence made with the Principal Secretary, School Education Department, Govt of Andhra Pradesh dated 21.6.2022, with regard to Hindi, Telugu, Urdu Pandit Training programmes. These programmes are not find a place in NCTE Regulations, 2014. As such these institutions are non-existent thereafter.
