

The Committee perused the records of the institution and observed that the institution was issued 1st Show Cause Notice dated 01.03.2019 and Final Show Notice dated 29.11.2019 for verification of infrastructure & instructional facilities created by the institution in response to the Revised Provisions Recognition Order (RPRO) issued vide order No. F.No/SRC/NCTE/APSO0233/B.Ed/AP/2015 / 65535 dt 26.05.2015 for consideration of issuance of continuation order.

The documents obtained from the institution against First Show Cause Notice and Final SCN were placed before SRC in its meeting held on 392^{nd} Meeting held on 15^{th} – 16^{th} December 2020. Even then the institution has not complied with the requirements as per provisions of the NCTE Regulations, 2014. Therefore, the Committee decided the following:-

1. The management has not shifted its institution to its own permanent building which is in violation of the NCTE Regulations, 2022, 3(C).

In addition to the above, the Committee also noted the reply submitted by the institution and found the following deficiencies: -

- 1. The institution has not submitted certified copy of land documents issued by concerned Tehsildar /Revenue Officer. (If the same are in Regional Language the institution is also required to submit notarized copy of English version of land documents).
- 2. The institution has submitted photocopy of Land Use Conversion Certificate.
 - (a) Survey No. not mentioned.
 - (b) Purpose of LUC is mentioned agricultural Land from the date of vide registration CS.1046/2001 date 16.05.2001
- 2. The institution has not submitted an attested/notarized copy of Non Encumbrance certificate issued by the Competent Authority.
 - (a) The institution has submitted photocopy of Building Plan but the same was not approved by the competent authority. As per Building Plan built up



area not sufficient for B.Ed 1 unit. Multipurpose Hall not mentioned in Building Plan.

- 3. The institution has submitted photocopy of Site Plan but not approved by competent authority.
- 4. The institution has submitted photocopy of Building Completion Certificate but survey no and Built up area not mentioned.
- 5. The institution has not submitted Letter regarding approval of the faculty issued by the affiliating body.
 - (a) The institution has not appointed the faculty of Performing Arts, Healthy & Physical Education and Fine Arts.
- 6. The institution has submitted copy of FDRs Rs 3 Lakhs and 5 Lakhs.
 - (a) FDR No.38863582122 Rs.3 Lakhs is individual name.
 - (b)FDR No.34236838930 Rs.5 Lakhs is Matured on 25.09.2019.
 - (c) Theinstitution is required to submit a "Form A" issued by the respective Bank Manger towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh towards Endowment Fund & Reserve Fund into joint account for a duration of 5 years along with a copy of the FDRs.
- 7. Domain name of the website being run by the institution not submitted.

Accordingly a withdrawal order No. F.SRO/NCTE/APS00233/B.Ed/AP/ 2020 / 122099-2105 dated 29.12.2020 issued to the institution

At the time of withdrawal the Govt. of Andhra Pradesh has not notified the admissions for the academic session 2020-21. As such the Committee decided to withdraw the recognition from the academic session 2020-21 onwards. If any withdrawal takes place once the admission process for that academic session is in progress withdrawal will be effective from the next academic session.

In view of the above, the Committee decided that in the withdrawal order No. F.SRO/NCTE/APS00233/B.Ed/AP/ 2020 / 122099-2105 dated 29.12.2020,para 16 which mistakenly written as next academic session, to be construed from the para 15 of

the withdrawal order i.e. it is effective from the present academic session i.e. 2020-2021. Accordingly the same be apprised to the Hon'ble High Court, Delhi. 172. Government Teacher Training Institute, Chittur, Palakkad District, Kerala (File No. AOSO0242, Course - Elementary) The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -The Committee perused the matter of the institute and decided to write a letter to the institution with a copy to the affiliating body and State Govt. to make admission in the Government Teacher Training Institute, Chittur, Palakkad District, Keralafor the academic session 2020-2021. The Committee also decided that an order to this effect be also uploaded in the SRC, Website immediately. Further a Show Cause Notice on standard 13 points be served on the institution for considering the issuance of RPRO. 173. Sri Krishna Mukteeswara College of Education, Mukteswaram 533211, East Godavari District, Andhra Pradesh The original files of the Institution along with other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the InstitutionSri Krishna Mukteeswara College of Education, Mukteswaram 533211, East Godavari District, Andhra **Pradesh** for B.Ed programme for 1 basic unit of 50 students.

The SRC also made the following resolutions: -



1. The SRC in its 395th meeting reviewed the issuance of RPRO to the Govt. Colleges of Education located in Tamil Nadu in the light of a letter addressed to the Chairperson, NCTE, New Delhi by the Principal Secretary, Department of Higher Education, Govt. of Tamil Nadu.

The SRC in its 393rd meeting resolved to request the Govt. of Tamil Nadu to fill all the vacant positions in Colleges of Education run by Government of Tamilandu immediately so as to ensure quality in teacher education. Till then the admissions to the government Colleges of Education may be deferred.

The Principal Secretary, Higher Education, Govt. of Tamil Nadu initiated process of recruitment and informed the same to the Chairperson, NCTE, New Delhi.

Keeping in view, the academic session, the positive attitude of the Government of Tamil Nadu and also as desired by the NCTE Hqrs, the SRC, NCTE reviewed the issue and resolved to allow the Govt of Tamil Nadu to go ahead with the admissions for the academic year 2020-2021in the Govt. Colleges of Education till further orders.

8. In the process of perusing the files pertaining to different TEIs in the jurisdiction area of SRC, the committee observed that many of the Govt. Colleges of Teacher Education, DIETs, Govt. aided institutions and University Department are functioning with skeleton teaching staff.

In view of the importance of Human resources to assure quality in Teacher Education, the Committee decided to requestthe State Govt. and University Authorities to initiate the process of recruitment in all its institutions and facilitate the SRC, NCTE to issue continuation of recognition order to the institutions managed by the Govt /Govt Aided/Universities.

Accordingly, the RD, SRC is advised to write a letter to the concern authorities of the State Govt.and Universities in the jurisdictional area of the SRC.
